AMENDMENT NO. 2

SECTION VIII. TERM

This MOU is effective as of January 12, 2022, and is extended from the original expiration date of June 30, 2023, to expire on June 30, 2025, but may be terminated earlier in accordance with provisions of Section IX of the MOU or when the contract/funding for EIIS ends.
