**AMENDMENT No. 1**  
**CONTRACT No. 24-861**  
**Healthcare General Building Job Order Contract**

The following are amendments to Contract No. 24-861 with Angeles Contractor, Inc.

**WHEREAS**, a consultant services contract (Contract) was entered into between San Bernardino County ("County"), and Angeles Contractor, Inc. (Consultant), on September 10, 2024, to provide Healthcare General Building Job Order Contracting Consultant Services.

**NOW THEREFORE**, the Contract is hereby amended as follows:

1. REPLACE SECTION V, FISCAL PROVISIONS, SUB-SECTION A, "Zone Adjustment Factors" definitions, with the following:

**Zone 1, Adjustment Factor 1:** Contractor shall perform any and all functions called for in the Contract in Non-Patient Care Areas during Normal Working Hours (7:00AM to 5:00PM Monday through Friday) in the quantities specified in individual Job Orders against this contract for the unit price sum specified in the CTC multiplied times the adjustment factor of:

1.0700

Utilize four decimal places

**Zone 1, Adjustment Factor 2:** Contractor shall perform any and all functions called for in the Contract in Non-Patient Care Areas during Other Than Normal Working Hours (5:01PM to 6:59AM Monday through Friday, Saturday, Sunday and County holidays) in the quantities specified in individual Job Orders against this contract for the unit price sum specified in the CTC multiplied times the adjustment factor of:

1.0800

Utilize four decimal places

**Zone 1, Adjustment Factor 3:** Contractor shall perform any and all functions called for in the Contract in Patient Care Areas during Normal Working Hours (7:00AM to 5:00PM Monday through Friday) in the quantities specified in individual Job Orders against this contract for the unit price sum specified in the CTC multiplied times the adjustment factor of:

1.3800

Utilize four decimal places

**Zone 1, Adjustment Factor 4:** Contractor shall perform any and all functions called for in the Contract in Patient Care Areas during Other Than Normal Working Hours (5:01PM to 6:59AM Monday through Friday, Saturday, Sunday and County holidays) in the quantities specified in individual Job Orders against this contract for the unit price sum specified in the CTC multiplied times the adjustment factor of:

1.3900
