### IT IS HEREBY AGREED AS FOLLOWS:

### **AMENDMENT NO. 4**

It is hereby agreed to amend Contract No. 22-662, effective December 19, 2023 as follows:

## **SECTION V. FISCAL PROVISIONS**

## Amend Section V, Paragraphs A and N to read as follows:

- A. The maximum amount payable under this Contract shall not exceed \$5,498,000, of which a portion will be federally funded, and shall be subject to availability of funds to the County. The consideration to be paid to Contractor, as provided herein, shall be in full payment for all Contractor's services and expenses incurred in the performance hereof, including travel and per diem. Funding for IG activities, in the amount of \$168,000, must be spent no later than September 30, 2024.
- N. Funding for IG activities expires September 30, 2024, therefore, the funding for IG program must be expended by September 30, 2024.

#### **SECTION VIII. TERM**

## Amend Section VIII. to read as follows:

This Contract is effective as of July 1, 2022 and expires June 30, 2025, but may be terminated earlier in accordance with provisions of Section IX of the Contract. The Contract term may be extended for two (2) additional one (1) year periods by mutual agreement of the parties. All funding pertaining to any IG activities must be spent by September 30, 2024.

All other terms and conditions of Contract No. 22-662 remain in full force and effect.

This Contract may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Contract. The parties shall be entitled to sign and transmit an electronic signature of this Contract (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Contract upon request.
