AMENDMENT NO. 2

It is hereby agreed to amend Contract No. 19-584 as follows:

SECTION V. FISCAL PROVISIONS

Amend Paragraph A. to read as follows:

A. The aggregate amount of payment under this Contract is a combined total for all Translation and Interpretation Contractors identified in the corresponding Board Agenda item and together shall not exceed \$4,750,000 of which \$3,562,500 may be federal/state funded and shall be subject to availability of funds to the County.
