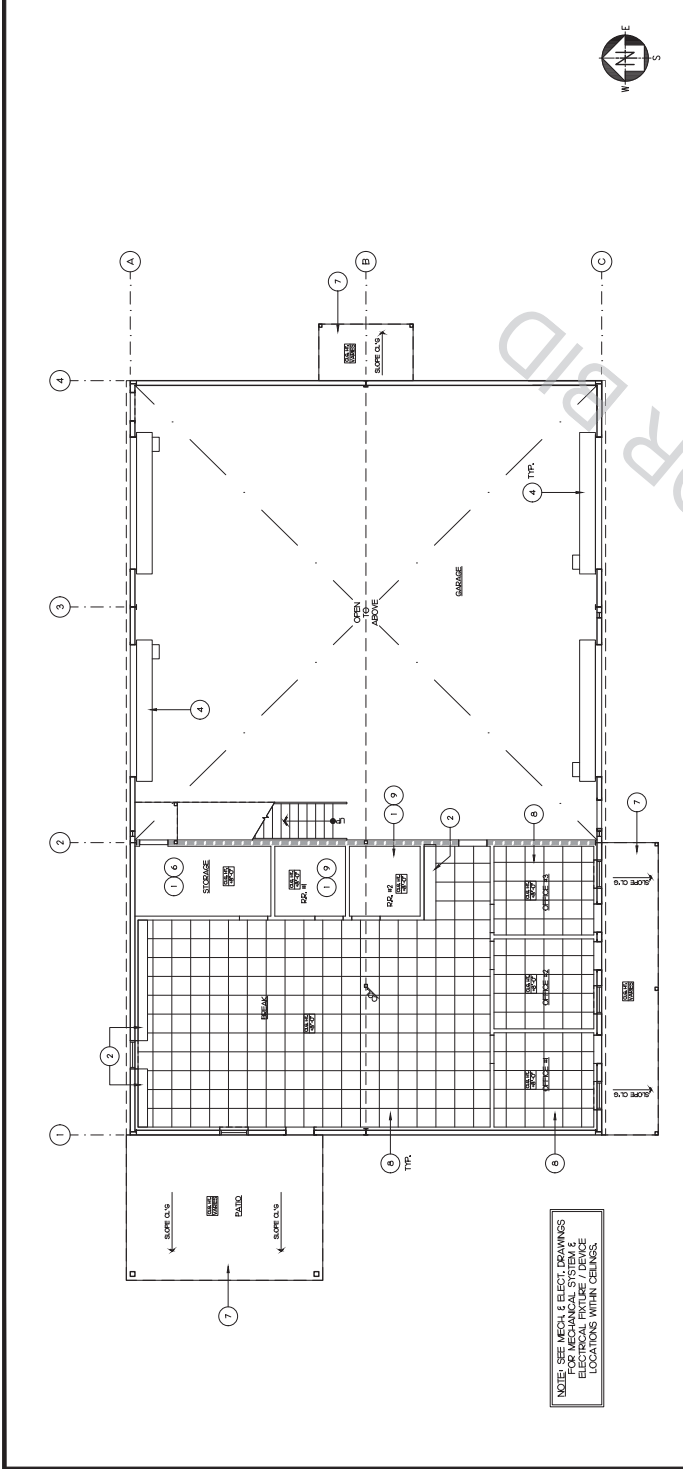

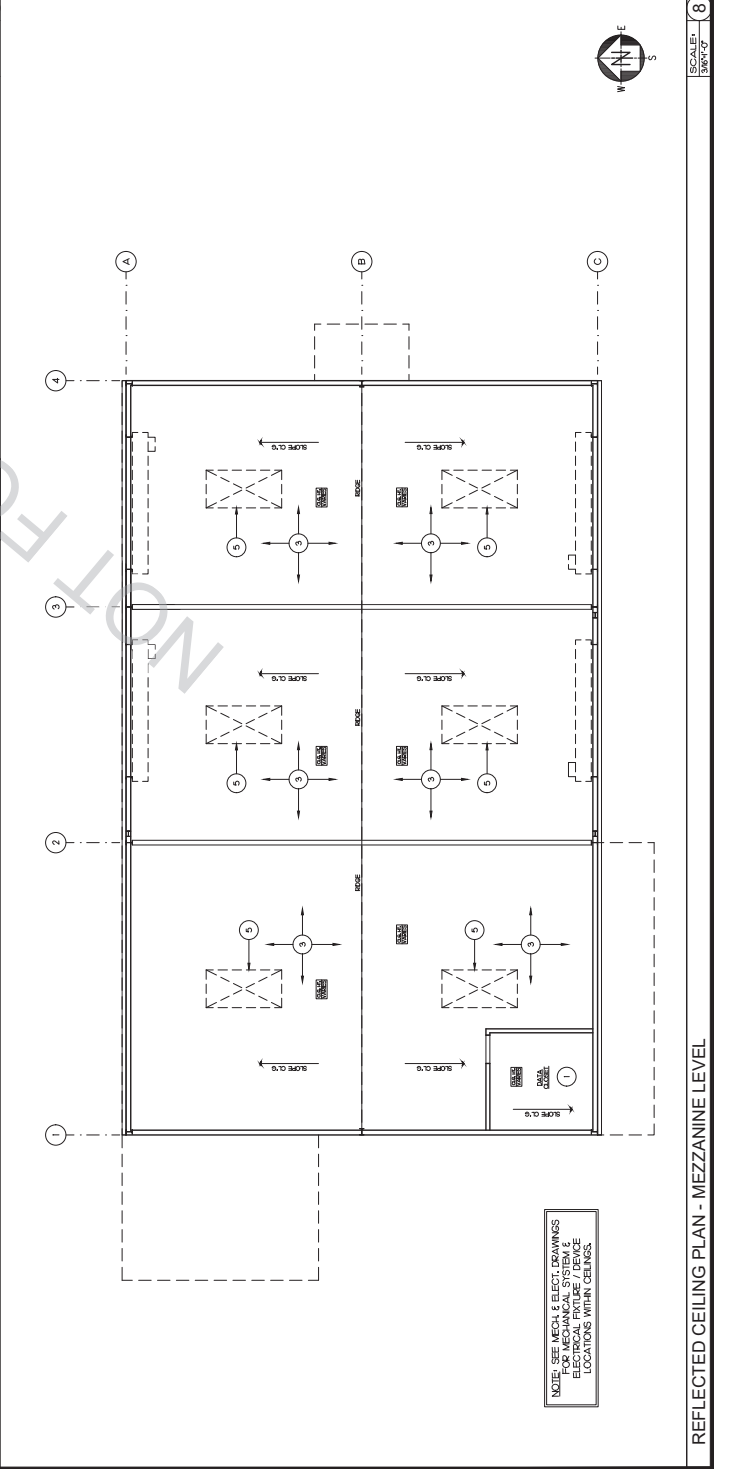

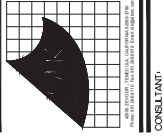


REFLECTED CEILING PLAN - GROUND LEVEL
