SECOND AMENDMENT TO CONTRACT

1. PARTIES. This Second Amendment (herein after referred to as "Agreement") to Arrowhead Regional Medical Center Contract Number 18-843 for Swisslog Healthcare Service and Support Agreement ("Contract"), dated October 1, 2018, by and between Translogic Corporation d/b/a Swisslog Healthcare, a Delaware corporation ("Swisslog"), and County of San Bernardino on behalf of Arrowhead Regional Medical Center ("Customer"). The Customer and Swisslog are referred to individually as a "Party" and collectively as the "Parties".

2. RECITALS AND PURPOSE.

- **2.1.** The Parties now desire to add or modify the Contract on the terms set forth in this Agreement.
- **2.2.** Capitalized terms used herein shall have the meanings given to them in the Contract, unless otherwise defined.

Accordingly, in consideration of the mutual promises and agreements set forth in the Agreement and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Swisslog and Customer agree to the terms and conditions set forth in the following paragraphs.

- **3. TERM.** Swisslog and Customer agree to extend the terms of the Contract effective December 14, 2020 through December 15, 2023.
- **4. RATIFICATION.** Except as modified herein, the Contract is hereby ratified and affirmed and remains in full force and effect.
- **5. HEADINGS & COUNTERPARTS.** The paragraph headings used in this Agreement are for convenience of reference only and shall not be deemed to define, limit or interpret the provisions or scope of the Contract. This document may be executed in multiple counterparts, each of which shall be deemed to be an original, but all of which, together, shall constitute one and the same instrument.
- **6. SUCCESSORS AND ASSIGNS.** This document shall be binding upon and shall inure to the benefit of, the parties hereto and their respective heirs, administrators, successors and assigns.
