
2024 EXHIBIT B MAP OF FRANCHISE AREA

This Exhibit contains a description of the Unincorporated County territory in which the Franchise Agreement may be exercised and of the exceptions therein, if any, where the Franchise Agreement will not be operative.

CFA 25 Waste Collection Franchise Area 25

Parcel No. 1

All that portion of San Bernardino County, State of California, described as follows:

Beginning at the Southwest corner of Section 31, Township 1 South, Range 3 East, San Bernardino Meridian, said point being on the Easterly boundary of the San Bernardino National Forest said point also being on the South boundary of the County of San Bernardino;

Thence North along said National Forest boundary and continuing along said boundary, following its various courses to the Northwest corner of Section 22, Township 2 North, Range 3 East, San Bernardino Meridian;

Thence East along section lines to the Northeast corner of section 24, Township 2 North, Range 6 East, San Bernardino Meridian, said point being on the boundary of the Twentynine Palms Marine Corps Base;

Thence East along the Southerly boundary of said Base to the North quarter corner of Section 20, Township 2 North, Range 7 East, San Bernardino Meridian;

Thence South along center section lines to the South quarter corner of Section 29, Township 2 North, Range 7 East, San Bernardino Meridian;

Thence East along the South line of said Section 29 to the Southeast corner of Section 29, Township 2 North, Range 7 East, San Bernardino Meridian;

Thence South along sectional lines to the Southwest corner of Section 33, Township 2 North, Range 7 East, San Bernardino Meridian;

Thence East along the South line of said Section 33 to the Southeast corner of Section 33, Township 2 North, Range 7 East, San Bernardino Meridian;

Thence South along sectional lines to the West South-South 1/64th corner of Section 10, Township 1 North, Range 7 East, San Bernardino Meridian;

Thence East to the East line of Section 10, Township 1 North, Range 7 East, San Bernardino Meridian, said point also being the East South-South 1/64th Corner of said Section 10;

Thence South along sectional lines to the Southeast corner of Section 34, Township 1 North, Range 7 East, San Bernardino Meridian;

CFA 25 Waste Collection Franchise Area 25

Thence West along Township line and sectional lines to the Southwest corner of Section 33, Township 1 North, Range 7 East, San Bernardino Meridian;

Thence South along sectional lines to the Southeast corner of Section 17, Township 1 South, Range 7 East, San Bernardino Meridian;

Thence West along sectional lines to the South quarter corner of Section 17, Township 1 South, Range 7 East, San Bernardino Meridian;

Thence South along center section lines to the South quarter corner of Section 32, Township 1 South, Range 7 East, said point being on the South boundary of San Bernardino County;

Thence Westerly along said County line to the **Point of Beginning**.

EXCEPTING therefrom that portion within the city limits of the Town of Yucca Valley.

Parcel No. 2

All that portion of San Bernardino County, State of California, described as follows:

Beginning at the intersection of the North boundary of the City of Twentynine Palms and the West line of Section 13, Township 1 North, Range 8 East, San Bernardino Meridian, said point also being the Southwest corner of Government Lot 9 of said Section 13;

Thence North along the West line of said Section 13 to the Northwest corner of Section 13, Township 1 North, Range 8 East, San Bernardino Meridian;

Thence East along the North line of said Section to the Northeast corner of Section 13, Township 1 North, Range 8 East, San Bernardino Meridian;

Thence North along sectional lines to the West quarter corner of Section 19, Township 2 North, Range 9 East, San Bernardino Meridian, said point also being the City boundary of Twentynine Palms, said point also being the south boundary of the Twentynine Palms Marine Corps Base;

Thence East along said Twentynine Palms Marine Corps Base and continuing along said boundary, following its various courses to the South line of Section 32,

CFA 25 Waste Collection Franchise Area 25

Township 2 North, Range 9 East, San Bernardino Meridian, said point also being the City boundary of Twentynine Palms;

Thence West along said City of Twentynine Palms boundary and continuing along said boundary, following its various courses to the Point of Beginning.
