Thereafter, the Agreement will automatically renew for an additional one (1) consecutive term of twelve (12) months (each, a "Renewal Term," together with the Initial Term, the "Term"), unless either Party provides to the other a written notice, at least thirty (30) days prior to the expiration of the then-current Renewal Term, of its intention not to renew this Agreement. Initial Term pricing discounts and incentives do not apply to any Renewal Term and pricing will be in accordance with then-current fees.
