ORDINANCE NO. _____

An ordinance of San Bernardino County, State of California, to amend Subsection 46.0506(d), Section 46.0508, Subsection 46.0604(h), and Subsection 46.1003(d) all of Title 4, Division 6 of the San Bernardino County Code relating to collection of delinquent fees on the tax rolls, penalties for violations, commercial organics recycling/diversion and resolution of subscriber complaints

The Board of Supervisors of the County of San Bernardino, State of California, ordains as follows:

SECTION 1. Subsection 46.0506(d) of the San Bernardino County Code is amended to read as follows:

(d) Pursuant to Health and Safety Code §§ sections 5473 through 5473a, the County elects to have delinquent fees, and the related penalties and interest and costs of collection, collected on the tax roll in the same manner, by the same person, and at the same time as, together with but not separately from, its general taxes. This election shall remain in effect until June 30, 202520305.

SECTION 2. Section 46.0508 of the San Bernardino County Code is amended to read as follows:

Except as otherwise allowed in <u>§§ sections</u> 46.13011401, 46.13021402, 46.13031403, and 45.13041404, it shall be unlawful for any person to fail or refuse to subscribe or pay for uniform handling service implemented under this Chapter. Such a failure or refusal to subscribe or pay for required uniform handling service shall subject such person to the penalties provided in <u>§ section</u> 46.15011601.

SECTION 3. Subsection 46.0604(h) of the San Bernardino County Code is amended to read as follows:
