#### BACKGROUND INFORMATION

On December 17, 2019 (Item No. 22), the Board of Supervisors approved the Chino Airport A-550 Remodel Project at Chino Airport as part of the First Quarter Budget Report – Maintenance and Capital Improvement Program for fiscal year 2019-20. After detailed review and investigation by the Real Estate Service Department – Project Management (RESD-PM), it was determined that the project required an increase in the amount of \$50,000 from \$500,000 to

\$550,000, based on unforeseen conditions of asbestos at the floor mastic and drywall requiring abatement in three areas of the administration building (A-550).
