RESOLUTION NO. 2025-131

RESOLUTION OF THE BOARD OF SUPERVISORS OF SAN BERNARDINO COUNTY TO ESTABLISH "NO PARKING" ZONE OF COMMERCIAL VEHICLES HAVING A GROSS WEIGHT RATING EXCEEDING 10,000 POUNDS ON PACIFIC STREET IN THE SAN BERNARDINO AREA

On Tuesday, June 10th, 2025, on motion of Supervisor Baca, Jr., duly seconded by Supervisor Hagman and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

WHEREAS, the San Bernardino County Department of Public Works completed a traffic engineering investigation regarding the parking of commercial vehicles along and around Pacific Street in the San Bernardino Area; and,

WHEREAS, the Board of Supervisors is authorized to establish parking restrictions on County roads pursuant to County Code Section 52.0128(a); and,

WHEREAS, the Board of Supervisors desires, based upon a traffic engineering investigation, to establish parking restrictions for commercial vehicles having a gross weight rating exceeding 10,000 pounds along Pacific Street, a residential district street, within the San Bernardino area.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of San Bernardino County as follows:

- 1. Due to conditions affecting the welfare of the public utilizing Pacific Street in the San Bernardino area, the Board of Supervisors, pursuant to a traffic engineering investigation, hereby finds and determines it necessary to:
 - a. Establish a "No Parking" zone of commercial vehicles having a manufacturer's gross vehicle weight rating exceeding 10,000 pounds on Pacific Street (629050) from the beginning of the curb return at the northeast corner of Pacific Street and Del Rosa Avenue and extending east 675 feet pursuant to County Code 52.0128(a).
- 2. The County Road Commissioner is hereby directed to place appropriate signs specifying applicable prohibitions on such streets and to perform such acts as are necessary to establish the parking restrictions above and implement the terms of this resolution.
