THIS AMENDMENT is entered into in the State of California by and between San Bernardino County, hereinafter called the County, and Walden Environment dba Walden Family Services referenced above, hereinafter called Contractor.

IT IS HEREBY AGREED AS FOLLOWS:**WITNESSETH:**

IN THAT CERTAIN **Contract No. 21-938** by and between San Bernardino County, a political subdivision of the State of California, and Contractor for Foster Family Agency Mental Health Services, which Contract first became effective January 1, 2022, the following changes are hereby made and agreed to, retroactively effective January 1, 2024:

- I. AGGREGATE FISCAL PROVISIONS are amended to read as follows:

II. ARTICLE V FUNDING AND BUDGETARY RESTRICTIONS, paragraphs I and J are hereby added to read as follows:

- I. The allowable funding sources for this Contract may include: Federal Financial Participation Medi-Cal, 2011 Realignment, and San Bernardino County's Department of Children and Family Services (CFS) through a Memorandum of Understanding. Federal funds may not be used as match funds to draw down federal funds.
- J. The Schedules A and B will be submitted to, and approved by, the Director or designee at a later date.

III. ARTICLE XVII PERSONNEL, paragraph J, is hereby amended and paragraphs L and M, are hereby added to read as follows:

J. Iran Contracting Act

IRAN CONTRACTING ACT OF 2010, Public Contract Code sections 2200 et seq. (Applicable for all Contracts of one million dollars (\$1,000,000) or more). In accordance with Public Contract Code section 2204(a), the Contractor certifies that at the time the Contract is signed, the Contractor signing the Contract is not identified on a list created pursuant to subdivision (b) of Public Contract Code section 2203 as a person (as defined in Public Contract Code section 2202(e)) engaging in investment activities in Iran described in subdivision (a) of Public Contract Code section 2202.5, or as a person described in subdivision (b) of Public Contract Code section 2202.5, as applicable.

Contractors are cautioned that making a false certification may subject the Contractor to civil penalties, termination of existing contract, and ineligibility to bid on a contract for a period of three (3) years in accordance with Public Contract Code section 2205.

L. Executive Order N-6-22 Russia Sanctions

On March 4, 2022, Governor Gavin Newsom issued Executive Order N-6-22 (the EO) regarding Economic Sanctions against Russia and Russian entities and individuals. "Economic Sanctions" refers to sanctions imposed by the U.S. government in response to Russia's actions in Ukraine (<https://home.treasury.gov/policy-issues/financial-sanctions/sanctions-programs-and-country-information/ukraine-russia-related-sanctions>), as well as any sanctions imposed under state law (<https://www.dgs.ca.gov/OLS/Ukraine-Russia>). The EO directs state agencies and their contractors (including by agreement or receipt of a grant) to terminate contracts with, and to refrain from entering any new contracts with, individuals or entities that are determined to be a target of Economic Sanctions. Accordingly, should it be determined that Contractor is a target of Economic Sanctions or is conducting prohibited transactions with sanctioned individuals or entities, that shall be grounds for termination of this agreement. Contractor shall be provided advance written notice of such termination, allowing Contractor at least 30 calendar days to provide a written response. Termination shall be at the sole discretion of the County.

M. Campaign Contribution Disclosure (SB 1439)

Contractor has disclosed to the County using Attachment III - Campaign Contribution Disclosure Senate Bill 1439, whether it has made any campaign contributions of more than \$250 to any member of the Board of Supervisors or other County elected officer [Sheriff, Assessor-Recorder-Clerk, Auditor-Controller/Treasurer/Tax Collector and the District Attorney] within the earlier of: (1) the date of the submission of Contractor's proposal to the County, or (2) 12

months before the date this Contract was approved by the Board of Supervisors. Contractor acknowledges that under Government Code section 84308, Contractor is prohibited from making campaign contributions of more than \$250 to any member of the Board of Supervisors or other County elected officer for 12 months after the County's consideration of the Contract.

In the event of a proposed amendment to this Contract, the Contractor will provide the County a written statement disclosing any campaign contribution(s) of more than \$250 to any member of the Board of Supervisors or other County elected officer within the preceding 12 months of the date of the proposed amendment.

Campaign contributions include those made by any agent/person/entity on behalf of the Contractor or by a parent, subsidiary or otherwise related business entity of Contractor.

IV. ADDENDUM I "SERVICE DESCRIPTION", Article IV "PROGRAM DESCRIPTION", paragraphs F, G and H are hereby added to read as follows:

F. Complex Care Capacity Building Efforts

-
1. Complex Care Capacity Building efforts provided funding to San Bernardino County (SBC) Children and Family Services (CFS) to expand the residential options for high needs foster youth who are residing in a foster home and require intensive specialty mental health services (SMHS).
 2. These residential options include:
 - a. Ten (10) Enhanced Intensive Foster Care (E-ISFC) homes for high needs foster youth who are Commercially Sexually Exploited Children (CSEC).
 - b. Ten (10) Intensive Services Foster Care (ISFC) for high needs foster youth.
 3. Only the FFA MHS program providers that have been selected by SBC CFS to participate in the Complex Care Capacity Building efforts will receive additional funding to meet the SMHS requirements of a E-ISFC and ISFC home.

G. Childrens Crisis Continuum Pilot (CCCP)

1. San Bernardino County in coordination with Riverside County submitted a joint Children's Crisis Continuum Pilot (CCCP) proposal and obtained funding that will be used by multiple programs to implement CCCP.
2. One critical program is the availability of E-ISFC/ISFC Homes that require intensive specialty mental health services.
3. Only the FFA MHS program providers that have been selected by SBC CFS to participate in the CCCP program, will receive additional funding to meet the SMHS requirements of a E-ISFC and ISFC home.

H. Enhanced-Intensive Foster Care Services (E-ISFC)/Intensive Foster Care Services (ISFC) homes.

1. E-ISFC/ISFC homes are for high needs foster youth and is tailored to the individualized needs of the foster youth with coordination/collaboration of services between providers and the Resource Parent (RP).
2. The Resource Parent, also referred to as a Professional Parent is specially trained to provide a higher level of care and support to a foster youth in their care including

providing intensive Early and Periodic Screening, Diagnosis, and Treatment (EPSDT) Specialty Mental Health Services (SMHS) via Therapeutic Foster Care services.

3. Youth will receive a high intensity of the SMHS that are listed under Mode 15 and Mode 5 Services as outlined in the contract below. These SMHS will be provided multiple times per day and up to 5-7 days a week.
4. Youth residing in a E-ISFC/ISFC homes require a weekly Child and Family Team Meeting (CFTM).

V. ADDENDUM I "SERVICE DESCRIPTION", Article V "DESCRIPTION OF SPECIFIC SERVICES TO BE PROVIDED", paragraphs C's title is hereby renamed to read as follows:

C. The role of a Parent Partner

VI. ATTACHMENT III "CAMPAIGN CONTRIBUTION DISCLOSURE (SB1439)", is hereby added.

Campaign Contribution Disclosure (Senate Bill 1439)

DEFINITIONS

Actively supporting the matter: (a) Communicate directly with a member of the Board of Supervisors or other County elected officer [Sheriff, Assessor-Recorder-Clerk, District Attorney, Auditor-Controller/Treasurer/Tax Collector] for the purpose of influencing the decision on the matter; or (b) testifies or makes an oral statement before the County in a proceeding on the matter for the purpose of influencing the County's decision on the matter; or (c) communicates with County employees, for the purpose of influencing the County's decision on the matter; or (d) when the person/company's agent lobbies in person, testifies in person or otherwise communicates with the Board or County employees for purposes of influencing the County's decision in a matter.

Agent: A third-party individual or firm who, for compensation, is representing a party or a participant in the matter submitted to the Board of Supervisors. If an agent is an employee or member of a third-party law, architectural, engineering or consulting firm, or a similar entity, both the entity and the individual are considered agents.

Otherwise related entity: An otherwise related entity is any for-profit organization/company which does not have a parent-subsidary relationship but meets one of the following criteria:

- (1) One business entity has a controlling ownership interest in the other business entity;
- (2) there is shared management and control between the entities; or
- (3) a controlling owner (50% or greater interest as a shareholder or as a general partner) in one entity also is a controlling owner in the other entity.

For purposes of (2), "shared management and control" can be found when the same person or substantially the same persons own and manage the two entities; there are common or commingled funds or assets; the business entities share the use of the same offices or employees, or otherwise share activities, resources, or personnel on a regular basis; or there is otherwise a regular and close working relationship between the entities.

Parent-Subsidiary Relationship: A parent-subsidiary relationship exists when one corporation has more than 50 percent of the voting power of another corporation.
