**AMENDMENT NO. 1 TO
PRICING AGREEMENT**

7555 Innovation Way
Mason, OH 45040

This Amendment No. 1 to Pricing Agreement ("**Amendment**"), entered into the date fully executed ("**Effective Date**"), is between ATRICURE, LLC, a Delaware limited liability company located at 7555 Innovation Way, Mason, OH 45040 ("**AtriCure**"), and San Bernardino County on behalf of Arrowhead Regional Medical Center ("**Buyer**"), and together with AtriCure, the "**Parties**", and each, a "**Party**".

WHEREAS, the Parties have entered into that certain Pricing Agreement, with an effective date of September 24, 2024 (the "**Existing Agreement**"); and

WHEREAS, the Parties hereto desire to amend the Existing Agreement on the terms and subject to the conditions set forth herein.

NOW, THEREFORE, in consideration of the premises set forth above and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows, effective as of the date this Amendment is fully executed ("Amendment Effective Date"):

1. **DEFINITIONS:** Capitalized terms used and not defined in this Amendment have the respective meanings assigned to them in the Existing Agreement.

2. **UPDATED PRICE LIST:** As of the Amendment Effective Date, the pricing list on Exhibit A in the Existing Agreement is hereby deleted in its entirety and replaced with the new pricing list attached hereto as Exhibit A.

3. **TERM:** For the avoidance of doubt, the Existing Agreement is effective through September 23, 2026, unless terminated or extended as provided in the Existing Agreement.

4. **MISCELLANEOUS:**

(a) This Amendment will be deemed effective as of the Amendment Effective Date. Except as expressly provided in this Amendment, all of the terms and provisions of the Existing Agreement remain in full force and effect and are hereby ratified and confirmed by the Parties.

(b) This Amendment shall inure to the benefit of and be binding upon each of the Parties and each of their respective permitted successors and permitted assigns.

(c) This Amendment constitutes the sole and entire agreement of the Parties with respect to the subject matter contained herein, and supersedes all prior and contemporaneous understandings, agreements, representations and warranties, both written and oral, with respect to such subject matter.

(d) This Amendment may be executed in one or more counterparts (including by means of the exchange of PDF signature pages), each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Amendment. The Parties shall be entitled to sign and transmit an electronic signature of this Amendment (including by exchange of PDF or other email transmission), which signature shall be binding on the Party whose name is contained therein. Each Party proving an electronic signature agrees to promptly execute and deliver to the other Party an original signed Amendment upon request.
