

**RESOLUTION NO. 2025-95**

**RESOLUTION OF THE BOARD OF SUPERVISORS  
OF SAN BERNARDINO COUNTY TO RESCIND MIDBLOCK CROSSWALK ON BAKER  
BOULEVARD IN THE BAKER AREA**

On Tuesday, May 20, 2025, on motion of Supervisor Hagman, duly seconded by Supervisor Baca, Jr., and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

**WHEREAS**, on January 11, 1966, the Board adopted Resolution No. 66-175, that, among other things, established a pedestrian crosswalk across Baker Boulevard at a point 1370 feet west of State Highway 127 in the Baker Area; and

**WHEREAS**, the Department of Public Works completed a traffic engineering investigation on March 5, 2025, regarding the existing conditions of the pedestrian midblock crosswalk across Baker Boulevard (150500) at a point 1370 feet west of State Highway 127 in the Baker Area; and

**WHEREAS**, the Board of Supervisors is authorized to remove crosswalks upon findings that the conditions because of which a crosswalk has been provided and maintained as provided in County Code section 52.0124(a) no longer exist; and

**WHEREAS**, the Board of Supervisors desires, based upon the traffic engineering investigation, to remove the pedestrian midblock crosswalk across Baker Boulevard (150500) at a point 1370 feet west of State Highway 127 in the Baker Area

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Supervisors of San Bernardino County as follows:

1. Due to conditions affecting the welfare of the public utilizing Baker Boulevard (150500) at a point 1370 feet west of State Highway 127 in the Baker Area, the Board of Supervisors, pursuant to a traffic engineering investigation, finds and deems it necessary to:
  - a. Rescind those portions of Resolution No. 66-175, dated January 11, 1966, that established a pedestrian crosswalk across Baker Boulevard (150500) at a point 1370 feet west of State Highway 127 in the Baker Area, and to remove the pedestrian midblock crosswalk across Baker Boulevard.
2. Directs the Road Commissioner to remove such markings, symbols, or signs from such crosswalk and to perform such acts as are necessary to implement the terms of the Resolution.
