

RESOLUTION NO. 2021-189

RESOLUTION OF THE BOARD OF SUPERVISORS OF SAN BERNARDINO COUNTY, ACTING IN ITS CAPACITY AS THE GOVERNING BODY OF COUNTY SERVICE AREA 70 HL (HAVASU LAKE), REPEALING RESOLUTION NO. 2011-114 AND AUTHORIZING REFUSE COLLECTION SERVICE CHARGES FOR COLLECTION ON THE FISCAL YEAR 2022-2023 TAX ROLL

On Tuesday, November 16, 2021, on motion of Supervisor Rutherford, duly seconded by Supervisor Cook and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California acting in its capacity as the governing body of County Service Area 70, Zone HL.

Section 1. The Board of Supervisors of the County of San Bernardino, acting in its capacity as the governing body of County Service Area 70, Zone HL, hereby finds and determines:

- a) That a written report has been prepared and filed with the Clerk of this Board which contains a description of each parcel of real property receiving the particular extended service from County Service Area 70, Zone HL and the amount of the charge for each parcel for Fiscal Year 2022-23.
- b) That required notice was properly given, and a public hearing was held this date and all interested persons desiring to make any comment or protest with respect to the imposition of such service charges were heard and that testimony and evidence for and against the proposed service charges, if any, were duly considered.

Section 2. The Board of Supervisors of the County of San Bernardino, acting in its capacity as the governing body of County Service Area 70, Zone HL, therefore, hereby resolves and orders:

- a) That the report on the service charges for County Service Area 70, Zone HL, is hereby confirmed at the following amounts for FY 2022-23:
 - 1) No charge or service for unimproved parcels; landowners not included in this category may request inclusion on a case-by-case basis from the Director of the Department of Public Works, Special Districts, subject to approval by this Board;
 - 2) \$268.24 per year, per improved parcels without onsite service for one pickup per week at community refuse location(s).
 - 3) \$2,958.55 per year, per improved commercial parcel with onsite service for one pickup per week (per four cubic yard bin).
 - 4) \$4,442.38 per year, per improved commercial parcel with onsite service for one pickup per week (per six cubic yard bin).
- b) That such charges, as confirmed, shall be collected on the tax roll at the same time and in the same manner as general ad valorem property taxes are collected for Fiscal Year 2022-23 in County Service Area 70, Zone HL.
- c) That future year charges will increase consistent with the following schedule through Fiscal Year 2025-26:

- d) That the Clerk of this Board is hereby directed to certify to the passage of this resolution and to forward a copy of same to each of the following:
 - 1) The Auditor-Controller/Treasurer/Tax Collector of the County of San Bernardino; and
 - 2) The Secretary of the Advisory Board of County Service Area 70, Zone HL.
- e) That the Clerk is hereby further directed to forward a certified copy of said report to the Auditor-Controller/Treasurer/Tax Collector of the County of San Bernardino.
- f) That Resolution No. 2011-14 is hereby repealed in its entirety upon January 5, 2022.
