

**RESOLUTION NO. 2021-194
RESOLUTION OF THE BOARD OF SUPERVISORS
OF SAN BERNARDINO COUNTY TO
ACCEPT ROADS WITHIN VARIOUS TRACTS IN THE LYTLE CREEK AREA
INTO THE COUNTY MAINTAINED ROAD SYSTEM**

On Tuesday November 16, 2021, on motion of Supervisor Baca, Jr., duly seconded by Supervisor Rowe and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

WHEREAS, section 941 of the Streets and Highways Code provides that no public or private road shall become a County highway until and unless accepted by appropriate action of the Board of Supervisors, or the Board's designee; and

WHEREAS, the roads located within the boundary of Tract Nos. 15900, 16845, 16845-1, 16845-2, 16845-5, 16978, 16978-3, 16978-4, 16978-5, 18039, 16977-2, 16977-3, 17771-2 and 19937 and hereinafter described, have been constructed, inspected and approved to County standards; and

WHEREAS, right-of-way for the roads located within Tract Nos. 15900, 16845, 16845-1, 16845-2, 16845-5, 16978, 16978-3, 16978-4, 16978-5, 18039, 16977-2, 16977-3, 17771-2 and 19937 has been dedicated to San Bernardino County; and

WHEREAS, the roads located within Tract Nos. 15900, 16845, 16845-1, 16845-2, 16845-5, 16978, 16978-3, 16978-4, 16978-5, 18039, 16977-2, 16977-3, 17771-2 and 19937 ensures that the appropriate infrastructure needed to support the existing land use is maintained.

BE IT RESOLVED, by the Board of Supervisors of San Bernardino County that the following roads located within Tract Nos. 15900, 16845, 16845-1, 16845-2, 16845-5, 16978, 16978-3, 16978-4, 16978-5, 18039, 16977-2, 16977-3, 17771-2 and 19937, within Rosena Ranch in the Lytle Creek area, are necessary to public convenience and, therefore, are accepted into the County Maintained Road System:
