#### 1 ORDINANCE NO. 2 An ordinance of San Bernardino County, State of California, to repeal and add Chapter 40 of Division 2 of Title 1 of the 3 San Bernardino County Code, relating to the establishment 4 and responsibilities of the Office of Revenue Recovery. 5 6 The Board of Supervisors of the County of San Bernardino, State of California, 7 ordains as follows: 8 9 SECTION 1. Chapter 40 of Division 2 of Title 1 of the San Bernardino County 10 Code is repealed. 11 12 SECTION 2. Chapter 40 is added to Division 2 of Title 1 of the San Bernardino 13 County Code, to read as follows: 14 CHAPTER 40: OFFICE OF REVENUE RECOVERY 15 Sections 16 12.4001 Office of Revenue Recovery Established. 17 12.4002 Director of Revenue Recovery. 18 12.4003 Responsibilities of the Director of Revenue Recovery. 19 12.4004 Authority of the Director of Revenue Recovery. 20 12.4001 Office of Revenue Recovery Established. 21 There is hereby created and established an Office of Revenue Recovery of San 22 Bernardino County, as a subordinate Division of the constituent department 23 denominated as the Office of the Auditor-Controller/Treasurer/Tax Collector (formerly 24 the Office of Central Collections, Ord. 3662, passed – 1996), to provide credit and 25 collection services for County departments, the Arrowhead Regional Medical Center 26 and the San Bernardino County Superior Court. The Office of Revenue Recovery shall 27 be referred to as the Revenue Recovery Division.

The Director of Revenue Recovery shall be the elected Auditor-Controller/Treasurer/Tax Collector, and shall be responsible and have authority for the Revenue Recovery Division.

### 12.4003 Responsibilities of the Director of Revenue Recovery.

The Director of Revenue Recovery shall be responsible for coordinating the administrative activities of, and for establishing and implementing administrative policy and procedures for, the Revenue Recovery Division. The Director of Revenue Recovery will be responsible to provide credit and collection services for County departments, the Arrowhead Regional Medical Center and the San Bernardino County Superior Court, as well as accounting and collections distributions of fines, forfeitures and penalties to other governmental entities for the Court-ordered portions collected.

### 12.4004 Authority of the Director of Revenue Recovery.

- (a) The Director of Revenue Recovery shall be the appointing authority over those employees within the Revenue Recovery Division whose appointment is not otherwise provided for by Charter or General Law. The Director of Revenue Recovery shall have the power to delegate in writing this appointing authority.
- (b) The Director of Revenue Recovery shall have the power of general administrative supervision and coordination over the operations within the Revenue Recovery Division. The Director of Revenue Recovery may direct such action as he or she deems appropriate to exercise any power or jurisdiction or to assume or discharge any responsibility vested in him or her by this Chapter.
- (c) Subject to the general direction of the County Chief Executive Officer, the Director of Revenue Recovery shall be responsible for the preparation and compilation of the annual budget of the Revenue Recovery Division and shall be responsible for its administration after adoption.
