2	An ordinance of San Bernardino County, State of California,
3	to amend Section 12.0102 of Chapter 1 of Division 2 of Title 1 of the San Bernardino County Code, relating to the
4	adjustment of boundaries of the supervisorial districts.
5	
6	The Board of Supervisors of the County of San Bernardino, State of California,
7	ordains as follows:
8	
9	SECTION 1. Section 12.0102 of the San Bernardino County Code is amended,
10	to read in its entirety as follows:
11	12.0102 Supervisorial Districts
12	(a) Pursuant to the provisions of the Fair And Inclusive Redistricting for
13	Municipalities and Political Subdivisions Act (California Elections Code sections 21500
14	et seq.) the boundaries of the supervisorial districts of San Bernardino County are
15	adjusted, changed and established as set forth in Map, considered by the Board of
16	Supervisors at multiple public hearings as required by law, and as reflected in Exhibits A
17	and B hereto, and they shall constitute and are hereby established as the boundaries of
18	the supervisorial districts of San Bernardino County for subsequent elections until
19	further readjustment is required by law.
20	(b) For purposes of this article, references to "tract" shall mean "census tract,"
21	as that demographic unit is defined by the United States Bureau of the Census for the
22	2020 Census and as described by maps and publications of the United States Bureau
23	of the Census. References to "block," "blocks" or "block groups" refer to those
24	demographic units, as defined by the United States Census Bureau for the 2020
25	Census and as described by maps and publications of the United States Census
26	Bureau.
27	
28	SECTION 2. All ordinances and resolutions, or parts thereof in conflict with this

3	SECTION 3. The Chief Executive Officer is directed to take all necessary steps
4	to give effect to this ordinance. If necessary to facilitate the implementation of this
5	ordinance, the Chief Executive Officer or his or her designee is authorized to make
6	technical adjustments to the district boundaries that do not substantively affect the
7	populations in the districts, the eligibility of candidates, or the residence of elected
8	officials within any district. The Chief Executive Officer shall consult with County
9	Counsel concerning any technical adjustments deemed necessary and shall advise the
10	Board of Supervisors of any such adjustments required in the implementations of the
11	districts.
12	
13	SECTION 4. This ordinance shall take effect thirty (30) days from the date of
14	adoption.
