AMENDMENT NO. 2

Section 1. Paragraph F.2 of Contract No. 18-589 (the "Contract") is amended to read as follows:

F. FISCAL PROVISIONS

The consideration to be paid to Contractor, as provided herein, shall be in full payment for all Contractor's services and expenses incurred in the performance hereof, including travel and per diem.

Section 2. All other terms and conditions of the Contract shall remain in full force and effect.
