**IT IS HEREBY AGREED AS FOLLOWS:**

**AMENDMENT No. 1**

Contract No. 18-904 for the provision of psychological and related services, including pre-employment screening, critical incident stress debriefing, counseling, hostage barricade negotiations incidents, fitness for duty examinations, and a variety of psychological training and/or classes by The Counseling Team International is hereby amended effective January 1, 2022 as follows:

- (1) To amend Section A.2 – CONSIDERATION, by deleting the last sentence in the provision and replacing it with the following:

The total consideration paid under this Contract shall not exceed \$2,506,400.

- (2) To amend Section A.3 – TERM, by deleting the provision and replacing it in its entirety as follows:

This Contract shall be for a term of four (4) years commencing on January 1, 2019 ("Effective Date") through December 31, 2022 ("Termination Date"). This Contract may be extended for one (1) additional one-year period upon mutual written agreement of the Sheriff and Contractor. Notwithstanding the foregoing, this Contract may be terminated at any time, with or without cause, by Sheriff or Contractor upon sixty (60) days advance written notice to the other party. In the event of termination each party shall fully pay and discharge all obligations in favor of the other accruing prior to the date of such termination, and each party shall be released from all obligations of the performance which would

otherwise accrue subsequent to the date of termination. Neither party shall incur any liability to the other by reason of termination.

Except as amended, all other terms and conditions of this Agreement remain as stated therein.

Due to the COVID-19 pandemic, pursuant to the Uniform Electronic Transaction Act (Cal. Civ. Code §§ 1633.1 to 1633.17), and the San Bernardino County Board of Supervisors Resolution No. 2020-030, the parties have agreed to the use of electronic facsimile, and/or digital signatures in the execution of the Contract and any of its subsequent amendments. Such signatures shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Agreement upon request.
