IT IS HEREBY AGREED AS FOLLOWS:

Amendment No. 1

WITNESSETH:

IN THAT CERTAIN: Contract No. 19-155 by and between the County of San Bernardino, now known as San Bernardino County ("County") and Armitage Tactical ("Contractor") for providing Training Courses, which first became effective April 1, 2019, the following changes are hereby made and agreed effective January 11, 2022:

I. SECTION F. FISCAL PROVISIONS, Paragraph F.1 is hereby amended to read as follows:

F.1 The maximum amount of payment under this Contract shall not exceed \$200,000, and shall be subject to availability of other funds to the County. The consideration to be paid to Contractor, as provided herein, shall be in full payment for all Contractor's services and expenses incurred in the performance hereof, including travel and per diem.

II. SECTION L. ELECTRONIC SIGNATURE is hereby added to read as follows:

This Contract may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Contract. The Parties shall be entitled to sign and transmit an electronic signature of this Contract (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name is contained therein.

III. Replace all references in the Contract to County from County of San Bernardino to San Bernardino County.

IV. All other terms, conditions, and covenants in Contract No. 19-155 remain in full force and effect.
