IT IS HEREBY AGREED AS FOLLOWS:

AMENDMENT No. 2

Contract No. 16-913, to provide Commissary Services by Aramark Correctional Services, LLC to the Sheriff/Coroner/Public Administrator, is hereby amended effective February 8, 2022 as follows:

(1) To replace Section D – TERM OF CONTRACT, in its entirety, with the following:

D. TERM OF CONTRACT AND TERMINATION FOR CONVENIENCE

The Contract shall commence on December 6, 2016 ("Effective Date") through February 29, 2024 ("Termination Date"). The Contract may be terminated earlier in accordance with provisions of the Contract. The County and the Contractor each reserve the right to terminate the Contract, for any reason, at any time during the term or any renewal extension, upon a one hundred and eighty (180) day written notice of termination to the other party. Either party may terminate the Contract upon a breach or default of the Contract by the other party, which is not cured within thirty (30) days after receipt by the defaulting party of a notice from the non-defaulting party, specifying the nature of such breach or default.

Such termination may include all or part of the services described herein. Upon such termination, payment will be made to the Contractor for services rendered and expenses reasonably incurred prior, up to, and including to the effective day of termination, at the rates and within the payment periods set forth in the Contract. Upon receipt of termination notice, Contractor shall promptly

discontinue services unless the notice directs otherwise. Contractor shall deliver promptly to County and transfer title (if necessary) all completed work, and work in progress, including drafts, documents, plans, forms, data, products, graphics, computer programs and reports.

Upon expiration or any termination of this Contract, the parties will negotiate a possible purchase of Contractor's usable inventory of products and supplies located on County's property.

- (2) To add sub-section K.3 to Section K ENTIRE AGREEMENT, as follows:
 - K.3 Due to the COVID-19 pandemic, pursuant to the Uniform Electronic Transaction Act (Cal. Civ. Code §§ 1633.1 to 1633.17), and the San Bernardino County Board of Supervisors Resolution No. 2020-030, the parties have agreed to the use of electronic facsimile, and/or digital signatures in the execution of the Contract and any of its subsequent amendments. Such signatures shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Agreement upon request.

Except as amended, all other terms and conditions of the Contract remain as stated therein.
