RESOLUTION NO. 2022-99

RESOLUTION OF THE BOARD OF SUPERVISORS OF SAN BERNARDINO COUNTY TO ESTABLISH A SPEED ZONE ON SUNSET ROAD, JOSHUA TREE AREA

On Tuesday June14, 2022, on motion of Supervisor Rowe, duly seconded by Supervisor Baca Jr. and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

WHEREAS, the Department of Public Works completed a traffic engineering investigation on both sides of Ivy Avenue from Ilex Street east to Cottonwood Avenue; Palms Avenue from Owen Street north to Ivy Avenue; and on Owen Street from Ilex Street east to Palms Avenue, in the Fontana area; and,

WHEREAS, the Board of Supervisors is authorized to establish parking restrictions on County roads pursuant to County Code Section 52.0128(a); and,

WHEREAS, the Board of Supervisors desires to establish a parking restriction on both sides of Ivy Avenue from Ilex Street east to Cottonwood Avenue; Palms Avenue from Owen Street north to Ivy Avenue; and on Owen Street from Ilex Street east to Palms Avenue, in the Fontana area; and,

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of San Bernardino County as follows:

1. Due to conditions affecting the welfare of the public utilizing Ivy Avenue in the Fontana area, the Board of Supervisors, pursuant to a traffic engineering investigation, deems it necessary to:

Establish a "No Stopping, Standing, or Parking" zone of commercial vehicles having a gross weight rating exceeding 10,000 pounds on both sides of Ivy Avenue (442600) from Ilex Street (434950) east to Cottonwood Avenue (257850); Palms Avenue (633470) from Owen Street (624550) north to Ivy Avenue (442600); and Owen Street (624550) from Ilex Street (434950) east to Palms Avenue (633470), in the Fontana area.

2. Direct the County Road Commissioner to perform such acts as are necessary to implement the terms of this resolution.
