# **RECOMMENDED CHANGES TO THE 2022-23 RECOMMENDED BUDGET**

This document includes recommended changes to the 2022-23 Recommended Budget Book for the San Bernardino County Fire Protection District (SBCFPD).

## STAFFING

A total of 22 new positions and 2 reclassifications of existing positions are requested. The new positions include the following:

- Fifteen (15) positions to support SBCFPD with the fuels reduction program, various activities within the Office of the Fire Marshal (OFM), emergency medical services, warehouse operations, various administrative/fiscal functions, and contract services to the City of Fontana. The cost of these positions will be funded through an increase in various departmental revenue sources and a cost savings from the deletion of three vacant positions (Position Numbers 30609, 50326 and 88057).
- Seven (7) positions for the Office of Emergency Services (OES) to enhance its ability to
  provide services in a post pandemic environment, including continued disaster response
  efforts, grant management, developing proactive County trainings, and partnering with
  other agencies. The cost of these positions will be funded through an increase in
  Discretionary General Funding.

## Description of new positions:

- Accounting Technician One position to assist OES in budgetary and accounting functions.
- Administrative Assistant One position to assist SBCFPD administrative staff with increased workload.
- Administrative Supervisor I One position to supervise the newly expanded administrative unit of OES.
- **Captain** Two positions (One position to perform forester duties and lead a fuels reduction crew focusing on community risk reduction; one position to provide additional fire protection/emergency medical services per the contract with the City of Fontana).
- **Deputy Fire Marshal** One position to plan, direct, and coordinate comprehensive program activities within OFM.
- **EMS Nurse Educator** One position to assist with the increasing demand for emergency medical services.
- Fire Equipment Specialist One position to assist with warehouse operations.

- Fire Investigator I One position to reduce the amount of overtime incurred by OFM staff.
- Fire Suppression Aide III Two positions to provide additional work for the fuels reduction crew.
- **Hazardous Materials Specialist II** Two positions are needed to assist OFM with regulating all hazardous waste generating facilities throughout the county.
- **Hazardous Materials Specialist IV/HMRT** One position is needed to provide adequate shift coverage for workload demands.
- Management Analyst One position for processing various SBCFPD data for analysis.
- **Media Specialist** One position to oversee social media and other outward facing information sharing for OES.
- **Payroll Specialist** Three positions to assist SBCFPD and OES with payroll-related workload demands.
- Staff Analyst I One position for support of workload within the Training/EMS Division.
- **Staff Analyst II** Two positions to support OES with contract management, budgetary functions, interdepartmental coordination, and grants.

- Rear Parking Lot Repavement at Station 42 in Yucca Valley (\$93,680).
- Roof Replacement at Station 23 in Grand Terrace (\$281,137).
- Roof Replacement at Station 161 in Upland (\$315,832).
- Restroom Remodel at Station 221 in San Bernardino (\$378,000).
- Sleeping Quarters Remodel at Station 222 in San Bernardino (\$319,212).
- Apparatus Bay Heater Installation at Station 224 in San Bernardino (\$72,500).

# OTHER ADJUSTMENTS

OES is requesting a budget increase for the following expenditures:

- Purchase of deployment kits for mobile satellite systems, which are needed to ensure the safety of these systems during deployment (\$120,000).
- Contract with a consultant for a Strength, Weakness, Opportunity, and Threat (SWOT) Analysis of OES. Among other things, this analysis will assist OES in developing organizational strategic goals (\$100,000).

These expenditures will be funded by a one-time increase in Discretionary General Funding of \$220,000.
