#### **AMENDMENT NO. 1**

It is hereby agreed to amend Contract No. 19-740, effective September 14, 2022, as follows:

# **SECTION F. FISCAL PROVISIONS**

## Paragraph F.1 is amended to read as follows:

F.1 The maximum amount of payment under this Contract shall not exceed \$4,300,000 for the total contract period, and shall be subject to availability of other funds to the County. The consideration to be paid to Contractor, as provided herein, shall be in full payment for all Contractor's services and expenses incurred in the performance hereof, including travel and per diem.
