## Project Description

**Project Title:** Merrill Ave. and Other Roads Project (H15022)

**Project Location:** On Merrill Ave. between Cherry Ave. and Catawba Ave.; Randall Ave. between Cherry Ave. and Poplar Ave. and Sequoia Ave between Hemlock Ave. and Beach Ave. In the Fontana area, of San Bernardino County, California (see Location Map).

**Project Description:** The San Bernardino County Public Works Department proposes to perform routine street maintenance and minor improvements in the Fontana area of San Bernardino County that generally include mill and overlay of asphalt concrete pavement; relocation of a flashing beacon; repairing spandrels and cross-gutters; upgrades to ADA ramps and replacement of storm drains. The proposed improvements may necessitate the removal of trees within County Right-of-Way. No traffic detours or nighttime construction are planned. No relocation of utilities is anticipated. Construction activities will occur on existing roads, sidewalks and previously disturbed areas. Construction duration is anticipated for approximately three (3) months. County of San Bernardino Development Code 83.01.80(g)(3): exempts noise from temporary construction, maintenance, repair, or demolition activities between 7:00 a.m. and 7:00 p.m., except Sundays and Federal holidays.
