RESOLUTION NO. 2022-220

RESOLUTION OF THE BOARD OF SUPERVISORS OF SAN BERNARDINO COUNTY TO ESTABLISH A NO STOPPING, STANDING, OR PARKING ZONE ON CAJON BOUELVARD AND DEVORE ROAD IN THE SAN BERNARDINO AREA

On Tuesday November 15, 2022, on motion of Supervisor Baca Jr., duly seconded by Supervisor Rutherford and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

WHEREAS, the Department of Public Works completed a traffic engineering investigation regarding the parking of vehicles along and around Cajon Boulevard and Devore Road in the San Bernardino Area; and

WHEREAS, the Board of Supervisors is authorized, pursuant to County Code Section 52.0118(a), to establish restrictions on County roads to prohibit stopping, standing or parking of vehicles on certain highways or portion thereof at all or certain hours of the day in order to facilitate the movement of traffic or to eliminate hazardous conditions; and,

WHEREAS, the Board of Supervisors desires, upon the basis of a traffic engineering investigation, that it is necessary to prohibit stopping, standing, and parking of any vehicle along the north side of Cajon Boulevard (199950) between Devore Road and Cajon Court; west side of Devore Road (297750) from Cajon Boulevard to approximately 400 feet north of Cajon Boulevard; and west side of Devore Road (297750) from 200 feet south of Santa Fe Avenue to approximately 480 feet south of Santa Fe Avenue.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of San Bernardino County as follows:

1. Due to conditions affecting the welfare of the public utilizing Cajon Boulevard and Devore Road, in the San Bernardino area, the Board of Supervisors, pursuant to a traffic engineering investigation, hereby finds and determines it necessary and hereby resolves to:

Establish a "No Stopping, Standing, or Parking" zone, pursuant to County Code Section 52.0118(a):

- a. Along the north side of Cajon Boulevard (199950) between Devore Road and Cajon Court;
- b. Along the west side of Devore Road (297750) from Cajon Boulevard to approximately 400 feet north of Cajon Boulevard;
- c. Along the west side of Devore Road (297750) from 200 feet south of Santa Fe Avenue to approximately 480 feet south of Santa Fe Avenue.
- 2. The County Road Commissioner is hereby directed to perform such acts as are necessary to establish the Parking Restrictions on Cajon Boulevard and Devore Road in the San Bernardino Area and to implement the terms of the resolution.
