#### **AMENDMENT NO. 3**

It is hereby agreed to amend Contract No. 20-1067, effective November 15, 2022, as follows:

#### **SECTION V. FISCAL PROVISIONS**

## Paragraph A is amended to read as follows:

A. The maximum amount of payment under this Contract shall not exceed \$1,455,738, of which \$1,455,738 may be federally funded, and shall be subject to availability of funds to the County.
