

RESOLUTION NO. 2022-218

**RESOLUTION OF THE BOARD OF SUPERVISORS
OF SAN BERNARDINO COUNTY TO
ESTABLISH “NO PARKING” ZONE OF COMMERCIAL VEHICLES HAVING A GROSS WEIGHT
RATING EXCEEDING 10,000 POUNDS ON GRAND AVENUE
IN THE CHINO AREA**

On Tuesday November 15, 2022, on motion of Supervisor Baca Jr., duly seconded by Supervisor Rutherford and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

WHEREAS, the Department of Public Works completed a traffic engineering investigation regarding the parking of commercial vehicles along and around Grand Avenue in the Chino Area; and

WHEREAS, the Board of Supervisors is authorized to establish parking restriction on County roads pursuant to County Code Section 52.0128(a); and,

WHEREAS, the Board of Supervisors desires, based upon a traffic engineering investigation, that it is necessary to establish a parking restriction of commercial vehicles exceeding a gross weight of 10,000 pounds on both sides of Grand Avenue from East End Avenue to Ramona Avenue in the Chino area, except for the portion maintained by City of Chino.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of San Bernardino County as follows:

1. Due to conditions affecting the welfare of the public utilizing Grand Avenue, in the Chino area, the Board of Supervisors, pursuant to a traffic engineering investigation, hereby finds and determines it necessary to:

Establish a “No Parking” zone of commercial vehicles having a gross weight rating exceeding 10,000 pounds on both sides of Grand Avenue (389200) from East End Avenue (312250) to Ramona Avenue (685750) in Chino area, except for the portion maintained by City of Chino.

2. Direct the County Road Commissioner to perform such acts as are necessary to implement the terms of the resolution.
