## <u>COUNTY AND CHIEF EXECUTIVE OFFICER GOALS & OBJECTIVES</u> Provide for the Safety, Health and Social Service Needs of County Residents.

#### FINANCIAL IMPACT

Approval of this item will not result in the use of additional Discretionary General Funding (Net County Cost). The public forum will be held during the regularly scheduled Board of Supervisors (Board) meeting on November 15, 2022. The estimated cost is minimal, including costs for publication in local newspapers and interpreter fees, which will be funded by the Sheriff/Coroner/Public Administrator's (Sheriff) 2022-23 Budget (4427001000).

## **BACKGROUND INFORMATION**

The Transparent Review of Unjust Transfers and Holds - TRUTH Act (Assembly Bill 2792) went into effect in California in January 2017, and requires that "[b]eginning January 1, 2018, the local governing body of any county, city, or city and county in which a local law enforcement agency has provided to the United States Immigration and Customs Enforcement (ICE), access to an individual during the last year shall hold at least one community forum during the following year, that is open to the public, in an accessible location, and with at least 30 days' notice to provide information to the public about ICE's access to individuals and to receive and consider public comment. (Govt. Code, § 7283.1, subd. (d)).

#### Transparent Review of Unjust Transfers and Holds - TRUTH Act (Assembly Bill 2792) Public Forum November 15, 2022

In 2021, the Sheriff provided ICE access to information and inmates housed in County detention facilities, when permissible under California and federal law. This action triggers the requirement for the County to schedule a public forum to receive and consider public comment about ICE's access to inmates. The Probation Department did not have responsive contact with ICE in 2021.

On October 4, 2022 (Item No. 47), the Board considered and scheduled the required forum for November 15, 2022, at 10:00 A.M. The public notice of the forum was posted in The San Bernardino Sun, The Press-Enterprise, and the Daily Press on October 5, 2022, and La Prensa Hispana on October 7, 2022, to meet the 30 day-advance notice requirement.
