

**RESOLUTION NO. 2022-216**

**RESOLUTION OF THE BOARD OF SUPERVISORS  
OF SAN BERNARDINO COUNTY TO  
ESTABLISH "NO PARKING" ZONE OF COMMERCIAL VEHICLES HAVING A GROSS WEIGHT  
RATING EXCEEDING 10,000 POUNDS ON SLOVER AVENUE  
IN THE BLOOMINGTON AREA**

On Tuesday November 15, 2022, on motion of Supervisor Baca Jr., duly seconded by Supervisor Rutherford and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

**WHEREAS**, the Department of Public Works completed a traffic engineering investigation regarding the parking of commercial vehicles along and around Slover Avenue in the Bloomington Area; and

**WHEREAS**, the Board of Supervisors is authorized to establish parking restriction on County roads pursuant to County Code Section 52.0128(a); and,

**WHEREAS**, the Board of Supervisors desires, based upon the traffic engineering investigation, to establish a parking restriction on the south sides of Slover Avenue from Spruce Avenue to the west approximately 335 feet; and the south sides of Slover Avenue from Spruce Avenue to the east approximately 330 feet in the Bloomington area.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Supervisors of San Bernardino County as follows:

1. Due to conditions affecting the welfare of the public utilizing Slover Avenue, in the Bloomington area, the Board of Supervisors, pursuant to a traffic engineering investigation, hereby finds and determines it necessary to:

Establish a "No Parking" zone of commercial vehicles having a gross weight rating exceeding 10,000 pounds on the south sides of Slover Avenue from Spruce Avenue to the west approximately 335 feet; and south sides of Slover Avenue from Spruce Avenue to the east approximately 330 feet in the Bloomington area.

2. Direct the County Road Commissioner to perform such acts as are necessary to implement the terms of the resolution.
