

RESOLUTION NO. 2022- 224

A RESOLUTION OF THE BOARD OF SUPERVISORS OF ALL BOARD GOVERNED COUNTY SERVICE AREAS, ADOPTING THE SAN BERNARDINO COUNTY MULTI-JURISDICTIONAL HAZARD MITIGATION PLAN DATED JULY 2017, AND AUTHORIZING FUTURE NON-SUBSTANTIVE AMENDMENTS TO THE PLAN

On Tuesday, November 15, 2022, on motion of Supervisor Baca Jr., duly seconded by Supervisor Rutherford and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, on behalf of all Board Governed County Service Areas, State of California.

WHEREAS, the preservation of life and property is an inherent responsibility of local, state, and federal government, including the County of San Bernardino Board Governed County Service Areas, and the San Bernardino County Office of Emergency Services; and

WHEREAS, the preparation of a local Multi-Jurisdictional Hazard Mitigation Plan (MJHMP) helps to define hazard mitigation measures in San Bernardino County which will reduce or eliminate loss of life and/or property; and

WHEREAS, this MJHMP update represents a comprehensive description of the commitment of the County, San Bernardino County Flood Control District, Board Governed County Service Areas, and San Bernardino County Fire Protection District to reduce, prevent or eliminate potential impacts of disasters caused by natural hazards; and

WHEREAS, the MJHMP update meets a Federal requirement under the Disaster Mitigation Act of 2000 for the County and its Board governed entities to be eligible to apply for federal funds for disaster recovery and mitigation assistance; and

WHEREAS, the MJHMP updates established a coordinated effort to support mitigation activities identifies measures to combat natural hazards within the county; and

WHEREAS, the MJHMP update is an extension of the State of California Multi-Hazard Mitigation Plan, and will be reviewed periodically and revised as necessary to meet changing conditions; and

WHEREAS, the Board of Supervisors agrees to adopt this MJHMP update and urges all officials, employees, public and private organizations, and citizens, individually and collectively, to do their share in furthering the preparation of hazard mitigation within San Bernardino County;

NOW, THEREFORE, BE IT RESOLVED THAT:

The Board of Supervisors of the County of San Bernardino, Board Governed County Service Areas, a public entity established under the laws of the State of California, hereby authorizes this MJHMP update to be adopted, that the County- Office of Emergency Services, Deputy Executive Officer is hereby authorized to implement future non-substantive amendments, recommended by the Federal Emergency Management Agency upon their final review, of the MJHMP update, that a copy of the Board of Supervisors' approved San Bernardino County MJHMP update be forwarded to the Federal Emergency Management Agency and the California Governor's Office of Emergency Services, that once approved the MJHMP update will be incorporated into the County's General Plan, and this plan will become effective immediately. While content may require revisions to meet the plan approval requirements, changes occurring after adoption will not require San Bernardino County Office of

Emergency Services to re-adopt any further iterations of the plan. Subsequent plan updates following the approval period for this plan will require separate adoption resolutions.
