

RESOLUTION NO. 2022-221

**RESOLUTION OF THE BOARD OF SUPERVISORS
OF SAN BERNARDINO COUNTY TO
ESTABLISH "NO PARKING" ZONE OF COMMERCIAL VEHICLES HAVING A GROSS WEIGHT
RATING EXCEEDING 10,000 POUNDS ZONE IN THE COLTON AREA**

On Tuesday November 15, 2022, on motion of Supervisor Baca Jr., duly seconded by Supervisor Rutherford and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

WHEREAS, the Department of Public Works completed a traffic engineering investigation on both sides of C Street, from approximately 300' west of Jackson Street to Tejon Avenue; both sides of Olive Street, from approximately 400' west of Jackson Street to Grand Avenue; and both sides of Grand Avenue from Stevenson Street south to approximately 400' north of F Street, in the Colton area; and

WHEREAS, the Board of Supervisors is authorized to establish parking restrictions on County roads pursuant to County Code Section 52.0128(a); and,

WHEREAS, the Board of Supervisors desires to establish a parking restriction on both sides of C Street, from approximately 300' west of Jackson Street to Tejon Avenue; both sides of Olive Street, from approximately 400' west of Jackson Street to Grand Avenue; and both sides of Grand Avenue from Stevenson Street south to approximately 400' north of F Street, in the Colton area; and,

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of San Bernardino County as follows:

1. Due to conditions affecting the welfare of the public utilizing C Street, Olive Street and Grand Avenue in the Colton area, as well as affecting the structural integrity of these roads, the Board of Supervisors, pursuant to a traffic engineering investigation, deems it necessary to:
 - a. Establish a "No Parking" zone of commercial vehicles having a gross weight rating exceeding 10,000 pounds on both sides of C Street (196650) from approximately 300' west of Jackson Street (445100) to Tejon Ave (807350) in the Colton area, pursuant to County Code Section 52.0128(a);
 - b. Establish a "No Parking" zone of commercial vehicles having a gross weight rating exceeding 10,000 pounds on both sides of Olive Street (612100) from approximately 400' west of Jackson Street (445100) to Grand Avenue (389050) in the Colton area, pursuant to County Code Section 52.0128(a); and
 - c. Establish a "No Parking" zone of commercial vehicles having a gross weight rating exceeding 10,000 pounds on both sides of Grand Avenue (389050) from Stevenson Street (773700) south to approximately 400' north of F Street (342300) in the Colton area, pursuant to County Code Section 52.0128(a).
2. Direct the County Road Commissioner to perform such acts as are necessary to implement the terms of the resolution.
