**AMENDMENT NO. 1 TO THE
MEMORANDUM OF UNDERSTANDING
BETWEEN THE SAN MATEO COUNTY BEHAVIORAL HEALTH
AND RECOVERY SERVICES DIVISION AND
SAN BERNARDINO COUNTY DEPARTMENT OF BEHAVIORAL HEALTH**

November 15, 2022

THE MEMORANDUM OF UNDERSTANDING (MOU), which became effective December 17, 2019, between the SAN BERNARDINO COUNTY DEPARTMENT OF BEHAVIORAL HEALTH, herein referred to as DBH, and SAN MATEO COUNTY BEHAVIORAL HEALTH AND RECOVERY SERVICES DIVISION, herein referred to as SAN MATEO COUNTY for the Cannabis Decoded Campaign is hereby amended in the following manner:

- I. ARTICLE 2 – Term and Termination, Section 2.1 Term, is hereby amended to read as follows:
This MOU, effective as of December 17, 2019, is extended from its original expiration date of December 16, 2022, to expire on December 16, 2023, but may be terminated earlier in accordance with provisions of Article 2.3 of this MOU. The MOU term may be extended for one (1) additional one-year period by mutual agreement of the parties.


