#### 1. ITEM NO. 1: LICENSE REQUIREMENTS

Contractors are advised of the following change/addition to Section A., Advertisement for Bids, Instructions to Bidders and Bid Proposal of the specifications:

1. Contractors are advised of the changes in State License(s) requirements for this project.
  - a. Advertisements for Bids, fifth paragraph shall now read as follows:  
Each bidder shall be a licensed contractor pursuant to the Business and Professions Code and shall be licensed in the following classification of contractor's license, for the work bid upon, and must maintain the license throughout the duration of the contract: California Class A (General Engineering) or C-34 (Pipeline) or Class B (General Building) with a C-36 Contractor's License. In order to be deemed responsive, the bidder must list, in the bid forms, at least three (3) projects of similar size and scope that it has completed over the last five years.
  - b. Instruction To Bidders, section 5 shall now read as follows:  
The undersigned hereby certifies that it is currently the holder of a valid California Class A (General Engineering) or C-34 (Pipeline) Contractor's License as a contractor in the State of California and that the license is the correct class of license for the work described in the project drawings and specifications.
  - c. Bid Proposal, State License Section shall now read as follows:  
The undersigned hereby certifies that it is currently the holder of a valid California Class A (General Engineering) or C-34 (Pipeline) or Class B (General Building) with a C-36 Contractor's License as a contractor in the State of California and that the license is the correct class of license for the work described in the project drawings and specifications. The undersigned also certifies that all subcontractor(s) listed under the Designation of Subcontractors section of the Bid Proposal are currently the holder of a valid contractor's license(s) in the State of California and the license is the correct class of license for the work to be performed by the subcontractor(s).

#### 2. ITEM NO. 2: SCOPE OF WORK

Contractors are advised of the following change/addition to Section A., Advertisement for Bids and Section G, Sheet 3:

1. Contractors are advised of the changes in the Scope of Work this project.
  - a. Advertisements for Bids, second paragraph shall now read as follows:  
**SCOPE OF WORK:** Contractor shall provide all supervision, labor, equipment, materials, and transportation necessary to complete the Project that includes removal of old toilets and install new with plumbed water and sewer lines and connections to existing underground utilities; install ADA fixtures as shown on the Bid Documents, including the Specifications.
  - b. Section G, Contract Drawings, Sheet 3, Scope of Work shall now read as follows:
    1. Scope of Work: To remove old toilets and install new with plumbed water and sewer lines and connections to existing underground utilities.
  
- **All provisions of this Addendum are hereby incorporated into the Contract documents, and Bidders shall account for all provisions pursuant to this Addendum in submitting their bid proposals.**


