Article XIII B of the California Constitution was amended by Proposition 111 to change the price and population factors used by the county in setting the appropriations limits.

CHANGE FACTOR COMPONENTS

PRICE FACTOR: The County has the option to select either (A) the Percentage Change in California Per Capita Personal Income or (B) the Percentage Change in the Local Assessment Roll Due to the Addition of Local Non-Residential New Construction.

POPULATION FACTOR: The County may choose the percentage change in one of the following: (1) the population within its jurisdiction, (2) the population within its jurisdiction combined with the population within all county borders contiguous to the County, or (3) the change in population within the incorporated portion of the County. For 2019-20, 2020-21, 2021-22, and 2022-23 the County selected to use option (3).

NOTES

- 1. The general fund base year adjustments, listed below, were made in 1988-89 to correct errors and incorporate omissions and interpretations by the Courts, County Counsel and the State Controller's Office:
 - * \$600,000 increase for cigarette tax revenue, inadvertently omitted as other state revenue.
 - * \$2,551,240 increase due to the addition of County Library's base year limit.
 - * \$95,000 decrease due to aid for agriculture included as tax proceeds.
 - * \$1,442,444 decrease due to the exclusion of federally restricted Public Assistance Revenues included in the base year as tax proceeds.
- 2. General Fund was \$25,724,955,766 decreased by \$2,000,000 for 2020-21 due to BAI #22, executed contract 21-114 approved on 2/9/21 for a net amount of \$25,722,955,766.
- 3. The base year limit of \$2,551,240 for the Library was established and separated from that of the General Fund in 1996-97 due to each fund having separate percentage change in the local assessment roll due to the addition of local non-residential new construction.
- 4. General Fund and Library appropriation limit for 2020-21 were decreased by \$6,025 and \$3,540 respectively due to the reorganization to include annexation to the City of Rancho Cucamonga and detachment from County Service Area 70 (Etiwanda Heights Neighborhood & Conservation Plan), per LAFCO 3241. BAI #3 05/05/20
- 5. General Fund appropriation limit was increased by \$279, and San Bernardino Fire Protection District Administration and Valley Service Zone were decreased by \$428 and \$1.938 respectively in 2020-21. Due to reorganization to Include annexation to the City of Loma Linda and detachment from the San Bernardino County Fire Protection District, its Valley Service Zone and its Zone FP-5, and County Service Area 70 (City-owned Parcels), per LAFCO 3239. BAI #40 05/19/20
- 6. General Fund, San Bernardino County Fire Protection District Administration, and Valley Service Zone were decreased by \$1,133, \$19, and \$86 respectively in 2020-21. The decreases were due to the reorganization to include annexation to the City of Fontana, Fontana Fire Protection District, West Valley Water District, and San Bernardino Valley Municipal Water District, and detachment from the San Bernardino County Fire Protection District, its Valley Service Zone and its Zone FP-5, and County Service Area 70 (I-15 Logistics Project) in 2020-21, per LAFCO 3243. BAI #37 11/17/20.
- 7. Mountain Service Zone and San Bernardino County Fire Protection District Administration for 2019-20 were decreased by \$1,759 and \$394, respectively due to the reorganization to include annexation to the Running Springs Water District and detachment from the San Bernardino County Fire Protection District, it's Mountain Service Zone, and its Zone FP-5, per LAFCO 3238, BAI #16 9/24/19.
- 8. The General Fund was decreased by \$428,100,000 for FY 2022-23 pursuant to subdivision (b) of Government Code Section 7903 which requires each county to include the full value of specified state subventions within their appropriations limits for the 2021-22 fiscal year and each subsequent fiscal year. The State Department of Finance (DOF) proposed in February 2023 to use the same state subventions reported for 2021-22 fiscal year.
- 9. General Fund and Library appropriation limit for FY 2022-23 were decreased by \$49 and \$37 respectively due to the reorganization to include Annexations to the City of Rancho Cucamonga, Cucamonga Valley Water District, Rancho Cucamonga Fire Protection District, and West Valley Mosquito and Vector Control District, and Detachments from Fontana Fire Protection District and County Service Area 70 (Speedway Commerce Center), per LAFCO 3256. BAI #28 09/27/22.
