IN THAT CERTAIN Contract No. 20-685 by and between San Bernardino County (County) and BELFOR USA Group, Inc. (Contractor) to provide on-call emergency environmental remediation and restoration services throughout the County which Contract first became effective September 1, 2020, the following changes are hereby made and agreed to as follows:

AMENDMENT NO. 4 TO CONTRACT NO. 20-685

- 1. AMEND Paragraph B.3.a. to read as follows:
 - a. Except for the projects described in a.1, a.2, and a.3, below, the total cost for individual projects shall not exceed \$60,000.
 - 1. Contractor shall clean San Bernardino County Fire Protection District supplies and equipment at various locations at 2824 East W Street in San Bernardino, which supplies and equipment will be identified by the San Bernardino County Fire Protection District Fire Chief or the Fire Chief's designee, as well as properly dispose of Items no longer needed, which items will be identified by the San Bernardino County Fire Protection District Fire Chief or the Fire Chief's designee. All costs for this work shall not exceed \$1,500,000.
 - Contractor shall clean San Bernardino County Fire Protection District supplies and equipment
 at various locations at Camp 6, which supplies and equipment will be identified by the San
 Bernardino County Fire Protection District Fire Chief or the Fire Chief's designee, as well as
 properly dispose of items no longer needed, which items will be identified by the San

- Bernardino County Fire Protection District Fire Chief or the Fire Chief's designee. All costs for this work shall not exceed \$95,000.
- 3. Contractor shall clean San Bernardino County Fire Protection District supplies and equipment at various locations at Camp 7, which supplies and equipment will be identified by the San Bernardino County Fire Protection District Fire Chief or the Fire Chief's designee, as well as properly dispose of items no longer needed, which items will be identified by the San Bernardino County Fire Protection District Fire Chief or the Fire Chief's designee. All costs for this work shall not exceed \$130,000.

All other provisions and terms of the Contract shall remain the same.

This Amendment may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Amendment.
