IT IS HEREBY AGREED AS FOLLOWS:

WITNESSETH:

IN THAT CERTAIN **Contract No. 17-336** by and between San Bernardino County, a political subdivision of the State of California, and CLARE|MATRIX for Early Intervention Outpatient Treatment, Intensive Outpatient Treatment and Recovery Services, which Contract first became effective July 1, 2017, the following changes are hereby made and agreed to:

- I. ARTICLE IV FUNDING, paragraphs K and L, are hereby amended to read as follows:
 - K. There is no change to the contract amount of \$1,867,800. Separately, there is an additional aggregate funding amount of \$800,000 that may be applied (but not necessarily ensured) for any client referred from San Bernardino County Children and Family Services for fiscal year 2022-23.
 - L. The revised Schedules A and B for fiscal year 2022-23 will be submitted to, and approved by, the Director or designee at a later date. All previously approved schedules remain in effect.

II. All other terms, conditions and covenants in the basic agreement remain in full force and effect.

This Agreement may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Agreement. The parties shall be entitled to sign and transmit an electronic signature of this Agreement (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Agreement upon request.
