IT IS HEREBY AGREED AS FOLLOWS:

AMENDMENT NO. 9

It is hereby agreed to amend Contract No. 14-613, effective July 1, 2023, as follows:

Section III. Fiscal Provisions, amend Paragraph A to read as follows:

- A. The maximum amount of reimbursement under this Contract shall not exceed \$4,535,431. The consideration to be paid to County, as provided herein, shall be full payment for all County's services and expenses incurred in the performance hereof, including travel and per diem. The maximum amount is a total dollar amount that includes the original contract amount and all subsequent amendments, broken down as follows:

Section V. Term is amended to read as follows:

This Contract is effective as of July 1, 2014 and is extended from its amended expiration date of June 30, 2023, to expire on June 30, 2024, but may be terminated earlier in accordance with provisions of Section VI of the Contract.

This Contract may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Contract. The parties shall be entitled to sign and transmit an electronic signature of this Contract (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Contract upon request.

All other terms and conditions of Contract No. 14-613 remain in full force and effect.
