IT IS HEREBY AGREED AS FOLLOWS:

WHEREAS, it is the policy of the Board of Supervisors (Board) to work with community partners through services provided by San Bernardino County (County) and contractual agreements to identify programs, projects, and initiatives that support the mission of the County, and to provide services to citizens that promote health, safety, economic well-being, education, recreation, and other public services that enhance the quality of life, and meet the needs of the County's citizens; and

WHEREAS, under Government Code sections 26224 and 26227, the Board may contract with certain entities to provide certain services to County residents; and

WHEREAS, on February 8, 2022 (Item No. 30), the Board approved Contract No. 22-90 (Contract) with the City of Fontana (Contractor) in the not-to-exceed amount of \$370,000 to provide funding for enhancements to Southridge Park for the period of February 8, 2022, through December 31, 2022, with the option for the County Chief Executive Officer to extend the terms of the Contract at the direction of the Contract Representative under Section C.13 of this Contract; and

WHEREAS, on December 7, 2022, the County Chief Executive Officer approved Amendment No. 1 to Contract No. 22-91 to authorize the Contractor's request to extend the Contract by an additional six (6) months, from December

31, 2022, to June 30, 2023; and

WHEREAS, the Contractor is requesting to extend the Contract term by an additional six (6) months from the current project termination date of June 30, 2023, to allow for the completion of services; and

WHEREAS, the Second District Supervisor has approved the additional extension of six (6) months from the current termination date of June 30, 2023; and

WHEREAS, under Section D., Term of Contract, the County Chief Executive Officer may extend the term of the Contract, in writing, to allow Contractor to complete all requirements in the Contract under certain conditions described below.

OPERATIVE PROVISIONS OF AMENDMENT NO. 2

NOW, THEREFORE, the County and Contractor mutually agree as follows:

Effective June 30, 2023, Contract No. 22-90 is hereby amended as follows:

1. Replace Section D of the Contract in its entirety with the following:

D. TERM OF CONTRACT

The services to be provided by Contractor shall commence February 8, 2022, and shall be completed by December 31, 2023, but may be terminated earlier in accordance with provisions of this Contract.

2. This Amendment No. 2 to Contract No. 22-90 (Amendment) may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, and such counterparts shall together constitute one and the same Amendment. The parties shall be entitled to sign and transmit an electronic signature of this Amendment (whether by facsimile, PDF or other email transmission), which signature shall be binding on the party whose name is contained therein. Each party providing an electronic signature agrees to promptly execute and deliver to the other party an original signed Amendment upon request.
