

**RESOLUTION NO. 2019-125**

**RESOLUTION OF THE BOARD OF SUPERVISORS  
OF THE COUNTY OF SAN BERNARDINO TO  
RESCIND AND ESTABLISH TRUCK WEIGHT LIMITS ON BRIDGES ON  
SEVEN OAKS ROAD IN THE BARTON FLATS AREA AND NATIONAL TRAILS HIGHWAY  
IN THE AMBOY AND ESSEX AREAS**

On Tuesday August 6, 2019, on motion of Supervisor Lovingood, duly seconded by Supervisor Rowe and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

**WHEREAS**, conditions affecting the welfare of the public utilizing National Trails Highway and Seven Oaks Road necessitate the revision of truck weight limits on bridges,

**NOW THEREFORE, BE IT RESOLVED** by the Board of Supervisors of San Bernardino County that

1. The portion identified as item 15 (bridge number 54C0401 on Seven Oaks Road) of Resolution No. 78-88, adopted on March 20, 1978, which established weight limits on bridges along Seven Oaks Road is rescinded;
2. The portion of Resolution No. 2004-050, identified as item 7 (bridge number 54C0262 Trada Ditch) and item 9 (bridge number 54C0264 Ettrick Ditch) of Amended Exhibit "A", adopted on March 23, 2004, which established weight limits on bridges along National Trails Highway is rescinded;
3. The portion identified as item B109 (bridge number 54C0313 Nicola Ditch) of Exhibit "A" of Resolution No. 2008-320, adopted on December 8, 2008, which established weight limits on bridges along National Trails Highway is rescinded;
4. Due to conditions affecting the welfare of the public utilizing Seven Oaks Road in the Barton Flats area, the Board of Supervisors pursuant to Caltrans Bridge Inspection reports deem it necessary to establish weight limits on Santa Ana River bridge number 54C0401 on Seven Oaks Road in the Barton Flats area, as listed in Exhibit "A", pursuant to Section 52.0126 of the County Code.
5. Due to conditions affecting the welfare of the public utilizing National Trails Highway in the Amboy and Essex areas, the Board of Supervisors pursuant to Caltrans Bridge Inspection reports deem it necessary to establish weight limits on County Bridge Trada Ditch bridge number 54C0262 and on Ettrick Ditch bridge number 54C0264 along National Trails Highway in the Amboy area; and on Nicola Ditch bridge number 54C0313 along National Trails Highway in the Essex area, as listed in Exhibit "B", pursuant to Section 52.0126 of the County Code.
6. Direct the County Road Commissioner to perform such acts as are necessary to implement the terms of this Resolution.
