## **HOUSING AUTHORITY RESOLUTION NO. 2019-124**

## A RESOLUTION OF THE BOARD OF GOVERNORS OF THE HOUSING AUTHORITY OF THE COUNTY OF SAN BERNARDINO APPROVING REVISIONS TO THE HOUSING SERVICES ADMINISTRATIVE PLAN GOVERNING THE HOUSING CHOICE VOUCHER SUBSIDIZED PROGRAMS

On Tuesday, August 6, 2019, on motion of Governor Lovingood, duly seconded by Governor Rowe and carried, the following resolution is adopted by the Board of Governors of the Housing Authority of the County of San Bernardino.

**WHEREAS**, the Housing Authority of the County of San Bernardino (HACSB) is required to maintain a Housing Services Administrative Plan which outlines regulations necessary to administer the Housing Choice Voucher subsidized programs on behalf of the United States Department of Housing and Urban Development (HUD); and

**WHEREAS**, HUD requires public housing agencies to amend their Administrative Plan to incorporate changes and define policy relative to administration of the Housing Choice Voucher subsidized programs; and

**WHEREAS**, HACSB desires to amend its policies and procedures as they relate to approved Moving to Work activities in order to reflect changes approved by HUD through the 2019 Annual Moving to Work Plan.

## NOW, THEREFORE, THE BOARD OF GOVERNORS OF THE HOUSING AUTHORITY OF THE COUNTY OF SAN BERNARDINO DOES RESOLVE AS FOLLOWS:

- Section 1. The Board of Governors finds that all of the facts set forth in the Recitals are true and correct, and are incorporated herein by reference.
- Section 2. The Board of Governors hereby approves the revisions to the Housing Services Administrative Plan governing the Housing Choice Voucher subsidized programs, a copy of which is attached hereto as Exhibit "A" and incorporated by reference herein.
- Section 3. This Resolution shall take effect immediately upon its adoption.
