**RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF SAN
BERNARDINO ACCEPTING THE MORONGO BASIN ACTIVE TRANSPORTATION PLAN AS
COMPLETE**

On Tuesday, August 6, 2019, on motion of Supervisor Lovingood, duly seconded by Supervisor Rowe and carried, the following resolution is adopted by the Board of Supervisors of San Bernardino County, State of California.

WHEREAS, The County of San Bernardino prepared the Morongo Basin Active Transportation Plan (ATP) for integration into the San Bernardino County Non-Motorized Transportation Plan administered by the San Bernardino County Transportation Authority; and

WHEREAS, the Morongo Basin ATP is compliant with California's Active Transportation Program guidelines established by the California Transportation Commission and the Regional Transportation Plan (RTP); and

WHEREAS, the San Bernardino County Non-Motorized Transportation Plan contains sections that encourage people to choose walking and bicycling as modes of transportation by increasing the proportion of trips accomplished by biking and walking; and

WHEREAS, the acceptance of the Morongo Basin ATP does not serve as an approval or commitment by the County to implement the projects contained therein, which are included for the purposes of calculating funding requirements; and

WHEREAS, the Morongo Basin ATP supports implementation of the Countywide Vision.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Supervisors of the County of San Bernardino finds and declares that the recitals set forth herein above are true and correct, accepts the Morongo Basin ATP as complete, and supports the Morongo Basin ATP being made a part of the San Bernardino County Non-Motorized Transportation Plan for the purpose of enabling the pursuit of future grant funding and to guide the development of a complete system of facilities for biking and walking.
