

Amendment to Agreement

This Amendment to Agreement (this "<u>Amendment</u>") dated September 1, 2019 ("<u>Amendment Effective</u> <u>Date</u>"), is entered into by and between *Vizient, Inc.*, a Delaware corporation ("<u>Vizient</u>") and *County of San Bernardino* ("<u>Member</u>"). Vizient and Member are sometimes referred to herein individually as a "<u>Party</u>" and collectively as the "<u>Parties</u>."

WHEREAS, Vizient and the County of San Bernardino on behalf of Arrowhead Regional Medical Center entered into that certain Associate Member Agreement, dated February 5, 2008 (as amended from time to time, collectively, the "Agreement"); and

WHEREAS, the Parties desire to amend the Agreement pursuant to the terms and conditions set forth in this Amendment.

NOW THEREFORE, in consideration of the mutual covenants and agreements set forth herein and other good and valuable consideration, the receipt and sufficiency of are hereby acknowledged, the Parties agree as follows:

- 1. <u>Recitals</u>. The foregoing recitals are incorporated herein by reference as if fully set forth in the body of this Amendment.
- 2. <u>Defined Terms</u>. All capitalized terms used in this Amendment shall have the same meanings ascribed to such terms in the Agreement, unless otherwise defined in this Amendment.
- 3. <u>Amendment</u>. The Agreement is hereby amended as follows:
 - A. <u>Term</u>. The Parties acknowledge and agree that the Agreement (prior to any modifications pursuant to this Amendment) currently expires on August 31, 2019. The Term of the Agreement is hereby extended to August 31, 2020.
 - B. All references to "County of San Bernardino on behalf of Arrowhead Regional Medical Center" shall be deleted and replaced with the "County of San Bernardino."
- 4. Miscellaneous.
 - A. This Amendment may be executed in a number of identical counterparts which, taken together, shall constitute collectively one agreement.
 - B. Except as herein expressly modified, all terms and conditions of the Agreement shall remain in full force and effect. To the extent an inconsistency exists between the terms and conditions of the Agreement and the terms and conditions of this Amendment, the terms and conditions of this Amendment shall govern.
