

1 RESOLUTION NO. 2019-135

2 RESOLUTION OF THE BOARD OF SUPERVISORS OF THE
3 COUNTY OF SAN BERNARDINO, STATE OF CALIFORNIA,
4 ESTABLISHING PARKING PENALTIES AND LATE PAYMENT
5 PENALTIES FOR PARKING VIOLATIONS.

6 On Tuesday August 20, 2019 on motion of Supervisor Gonzales duly seconded
7 by Supervisor Rowe and carried, the following resolution is adopted:

8 SECTION 1. The Board of Supervisors of the County of San Bernardino hereby
9 finds and determines:

10 a) Pursuant to Section 40203.5 of the California Vehicle Code, the Board of
11 Supervisors shall set forth the specific penalties which will be assessed for violation of
12 parking regulations of the California Vehicle Code (VC) and San Bernardino County
13 Code (CC) and the amount of penalties for late payment thereof.

14 SECTION 2. The Board of Supervisors of the County of San Bernardino,
15 therefore, hereby resolves and orders:

16 a) That the penalties for violation of parking regulations shall be as follows:
