EMERGENCY ANIMAL SUPPLY DEPOSIT TERMS AND CONDITIONS

This Emergency Animal Supply Deposit Agreement Terms and Conditions designates San Bernardino County, Dept. of Public Health, Animal Care and Control Division (receiving organization) as the "Depositee" and shall be effective this 18 day of December , 2019.

Depositee will receive a steel cargo shipping container with the non-perishable emergency animal sheltering supplies listed on Appendix "A" hereto (hereinafter, "Supplies"). Said delivery shall be made to the following location: Yucca Valley Animal Shelter, 4755 Malin Way, Yucca Valley, CA 92284

Any and all expenses associated with storing of the Supplies shall be borne solely and exclusively by Depositee.

The Supplies may only be utilized for emergency animal sheltering needs within the State of California, and only during one of the following four circumstances (hereinafter, "Qualifying Events"):

- (a) A state of emergency declared by a local emergency authority;
- (b) A state of emergency proclaimed by the Governor of the State of California;
- (c) A state of emergency declared by the President of the United States;
- (d) A training exercise in which emergency responders are practicing setting up an emergency animal shelter to address the circumstances set forth in (a-c), above.

Depositee will share supplies during the Qualifying Events listed in Item 3 (a-d), above, with other municipalities for mutual aid purposes at the request of a municipality or at the direction of the California Governor's Office of Emergency Services.

During and after a Qualifying Event, Depositee will retain as many of the Supplies as possible, and will clean and disinfect cages and other cleanable Supplies so that they may be restored—as best as reasonably possible—for future use in another Qualifying Event.

In the event that any of the Supplies are damaged, lost, stolen, or depleted, Depositee will attempt to replace said Supplies with identical (or, if unavailable, substantially similar) Supplies...

Depositee shall be solely and exclusively responsible for any injury, illness, or death caused to any human being or animal as a result of Depositee's use, storage, maintenance, or transportation of the Supplies.
