**IT IS HEREBY AGREED AS FOLLOWS:**

**AMENDMENT NO. 1**

It is hereby agreed to amend Contract No. 18-395, effective December 18, 2019, as follows:

Paragraph A is amended to read as follows:

- A. The maximum amount of payment under this Contract shall not exceed \$785,056, of which \$635,895 may be federally funded, and shall be subject to availability of funds to the County. The consideration to be paid to Contractor, as provided herein, shall be in full payment for all Contractor's services and expenses incurred in the performance hereof, including travel and per diem. These funds are divided as follows:
