Briefly describe the general nature of the contract: The Second Amendment to the License Agreement modifies installed equipment by adding an antenna with additional license fees to commence on the earlier of equipment installation or on January 1, 2020, extends the term of the license agreement for the period of January 1, 2020 through December 31, 2024 following a permitted holdover from December 1, 2019 through December 31, 2019, adjusts the license fees for the extended term, and adds three five-year automatic options to extend the term of the license unless either party gives 180 days prior written notice to the other to terminate.

SECOND AMENDMENT TO LICENSE AGREEMENT

This Second Amendment (the "Second Amendment") to that certain License Agreement dated January 11, 2005 by and between American Towers, Inc. and County of San Bernardino, as amended by that certain First Amendment to License Agreement dated April 26, 2017 (collectively, the "Agreement") is made and entered into as of the latter signature date hereof, by and between American Tower Management, LLC, a Delaware limited liability company, as successor-in-interest to American Towers, Inc. (the "Licensor") and County of San Bernardino (the "Licensee") (collectively, the "Parties").

RECITALS

WHEREAS, Licensor represents that it owns a certain communications tower and leases a certain parcel of land located at 12.5 miles west of Searchlight with an address of 9995 State Highway 164, Searchlight, NV 89046-0828 more commonly known to Licensor as the SEARCHLIGHT, NV tower site (the "Tower Facility"); and

WHEREAS, Licensor and Licensee entered into the Agreement for the use of a certain portion of the Tower Facility which term expired on November 30, 2019; and has continued on a permitted month-to-month holdover and

WHEREAS, Licensee desires to modify its equipment at the Tower Facility ("Modified Equipment"); and

WHEREAS, the Parties agree that as consideration for Licensee's Modified Equipment, the current Monthly License Fee payable under the Agreement shall be increased as set forth herein; and

WHEREAS, the Parties agree to renew the term of the Agreement for five years, following a permitted one (1) month holdover period with Licensor consent, and add three renewal option terms of five years each thereafter, among other things, all on the terms and conditions as set forth herein.

NOW THEREFORE, in consideration of the foregoing promises and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties hereto agree as follows:

Α. Modified Equipment

- 1) Licensor and Licensee agree and acknowledge that Licensee shall modify its equipment for a final installed configuration pursuant to Exhibit A-2.
- 2) Licensor and Licensee agree and acknowledge that Exhibit A-1 to the Agreement is hereby deleted in its entirety as of the date this Second

Amendment is fully executed and shall be replaced with Exhibit A-2 attached hereto and incorporated by this reference. In the event of inconsistency or discrepancy between the Exhibit A-2 and Licensee's equipment information set forth in the Agreement, the Exhibit A-2 shall control.

3) Effective upon the earlier to occur of: i) commencement of installation of the Modified Equipment or ii) January 1, 2020 ("Modified Equipment Commencement Date") the Monthly License Fee shall be increased by Three Hundred Sixty and 00/100 Dollars (\$360.00) per month ("Modified Equipment Increased Fee"). The Modified Equipment Increased Fee for any fractional month at the beginning or end of the period shall be appropriately prorated on a daily basis.

B. Renewal Term and Renewal Term Options

- With Licensor express consent granted herein, the term of this Agreement shall continue under a month-to-month holdover period from December 1, 2019 through December 31, 2019 at a monthly rental amount of Five Thousand Four Hundred Fifty-Three and 00/100 Dollars (\$5,453.00) per month.
- 2) Licensor and Licensee agree to renew the term of the Agreement for a period of five (5) years, commencing on January 1, 2020 ("the Third Renewal Term Commencement Date") and ending on December 31, 2024 (the "Third Renewal Term").
- 3) Licensor and Licensee agree that Licensee shall have three (3) additional periods of five (5) years each (each a "Renewal Term") to further renew the Agreement after the Third Renewal Term.
- 4) Immediately following the expiration of the Third Renewal Term, the Agreement shall automatically be renewed for each Renewal Term unless either Party gives the other one hundred eighty (180) days written notice of termination prior to the expiration of the then current term.
- 5) Effective on January 1, 2020, the Monthly License Fee, which includes the fee for the Modified Equipment, shall be Five Thousand Eight Hundred Thirteen and 00/100 Dollars (\$5,813.00) per month. The Monthly License Fee shall be adjusted on January 1, 2021 and on each anniversary thereafter by the Annual Escalator of three percent (3%). The Monthly License Fee for any fractional month at the beginning or end of the term shall be appropriately prorated on a daily basis.

C. <u>Miscellaneous</u>

1) Licensor and Licensee agree and acknowledge that all future payments of the
