

MULTIPLE PRODUCT PURCHASE AGREEMENT

This Multiple Product Purchase Agreement (the "**Agreement**"), effective as of <u>December 17</u>, 2019 (the "**Effective Date**"), is by and between Integra LifeSciences SalesLLC, a Delaware corporation with an address of 311 Enterprise Drive, Plainsboro, New Jersey 08536 ("**Integra**") and the County of San Bernardino, a political subdivision organized and existing under the constitution and the laws of the State of California, on behalf of its Arrowhead Regional Medical Center ("**County**"), as set forth on Schedule 1.

WHEREAS, County desires to purchase certain products (as set forth in Schedule 2) (each hereinafter referred to as a "**Product**" and collectively as the "**Products**"); and

WHEREAS, Integra desires to provide such Products to County on the terms hereinafter provided.

NOW THEREFORE, Integra and County, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and intending to be legally bound, agree as follows:

- 1. <u>Contract Year</u>. This Agreement shall have three (3) Contract Years (as defined below). For purposes of this Agreement, the first Contract Year shall begin on the Effective Date and end twelve (12) months thereafter; the second and third Contract Years shall begin on the next day following the end of the previous Contract Year and end twelve (12) months thereafter (collectively, the "Contract Years" and each, individually, a "Contract Year"). This Agreement shall terminate on <u>December 16, 2022</u> (the "End Date").
- 2. <u>Pricing and Discounts.</u> Subject to the terms of this Agreement, County will pay Integra the prices as set forth in Schedule 2. While Integra shall have the right, in its sole discretion, to increase the list prices on any or all of its products at any time during the term of the Agreement, County shall only be subject to price increases for the Products in Schedule 2 as set forth herein.
- a. In order to qualify for the discounts listed on Schedule 2 for a particular Product for a Contract Year, County shall purchase from Integra the minimum amount of such Product, or alternatively, the minimum amount of a combination of Products within a Product Category as set forth on Schedule 3.
- b. The discount for each Product will be taken at the time of the shipment of such Product and disclosed on the invoice Integra sends to County in accordance with Section 6.b. Integra shall have the right to monitor County's minimum purchase requirements on a quarterly basis to determine if County is purchasing the required percentage of Products or alternatively, of a combination of Products. Should the County fail during the term of this Agreement to purchase the required minimum quantities set forth on Schedule 3 for any Contract Year, at the end of the Contract Year, on a per-Product basis, Integra shall have the right to reduce any discount upon giving thirty (30) days' notice or terminate the Agreement pursuant to Section 7 below.
- c. The minimum purchase requirements listed on Schedule 3 for each Product for each Contract Year, or alternatively, for a combination of Products for each Contract Year, shall entitle County only to the discount available for such Product(s) for that Contract Year. County is not required to purchase any of the Products listed on Schedule 2 (except insofar as such minimum purchases are required to earn the discounts set forth on Schedule 3).

- d. County acknowledges that it is the intent of the parties that this Agreement will comply with the "anti-kickback" statute pertaining to the Medicare and Medicaid programs and the safe harbor for discounts contained in 42 CFR § 1001.952(h).
- 3. Payment Terms and Shipping. All payments under this Agreement are due net sixty (60) days from the date of the invoice and shall be made by check, ACH transaction or bank wire transfer to the address or bank remit instructions referenced on our invoice. Shipping terms are FOB Origin, and risk of loss and title shall pass from Integra at such FOB locations. For the avoidance of doubt, Integra shall bear all risk of loss or damage to the Products while in transit. Shipping costs are prepaid by Integra and will be invoiced to the County. County agrees to pay such shipping costs net sixty (60) days from the date of the invoice. Upon County's receipt of any Products shipped hereunder, County shall inspect the goods and notify Integra in writing within five (5) days after the goods have been received by County of any claims for shortages, defects or damages and shall hold the goods for Integra's written instructions concerning disposition.
- 4. Ordering. County agrees to order all Products through Integra Customer Service at (800) 997-4868, or as otherwise directed by Integra from time to time. In the event County is directed to issue a purchase order for Products, the terms of such purchase order shall not be binding on the parties except for the following: name of Product, quantity ordered and delivery address. No modification of, addition to, or waiver of, any of the provisions of this Agreement shall be effected by the acknowledgement or acceptance of any purchase order or other form containing additional or different terms or conditions to those contained herein, whether or not signed by an authorized representative of either party.
- 5. <u>Use of Products</u>. County agrees to use the Products in accordance with the requirements of the Product packaging instructions and labeling.
- 6. <u>Representations, Warranties and Covenants Regarding Discounts</u>. In addition to the statement of the intent of the parties set forth in Section 2, the parties hereto represent, warrant and covenant as follows:
- a. Representations, Warranties and Covenants of County. County represents and warrants that it is an entity that reports its costs on a cost report required by the Department of Health and Human Services or a State agency, as described in 42 CFR § 1001.952(h)(1)(i). County acknowledges that Integra has informed it of its obligations to report discounts earned on Product purchased from Integra pursuant to this Agreement, and represents and warrants, covenants and agrees that County will comply with all of the standards set forth in the requirements for establishment of safe harbor for discounts set forth more fully at 42 CFR §§ 1001.952 (h)(1)(i)(A) through (D).
- b. Representations, Warranties and Covenants of Integra. Integra represents, warrants, covenants and agrees that it will fully and accurately report discounts earned by the County on goods purchased from Integra pursuant to this Agreement (the Products) on invoices or statements submitted to the County in connection with such purchases, and will comply otherwise with all of the standards set forth in the requirements for establishment of safe harbor for discounts set forth more fully at 42 CFR §1001.952(h)(2)(ii).

7. Term and Termination.

a. <u>Term.</u> The term of this Agreement shall commence on the Effective Date and, unless otherwise terminated as provided herein, shall continue in full force and effect until the End Date specified in Section 1. This Agreement may be extended for a maximum of two (2) additional one year periods upon the mutual written agreement of the parties, which agreement may include a renegotiation of the prices of the Products.

b. Termination.

i. <u>Termination Rights</u>.

- 1. Breach. In the event that this Agreement is materially breached by either party, the nonbreaching party may give the breaching party written notice requiring it to remedy such breach. If such breach is not fully remedied within sixty (60) days after receipt of such notice or the parties have not agreed on a plan to remedy such breach, the nonbreaching party shall, in addition to other remedies available to it, be entitled to terminate this Agreement upon written notice thereof to the breaching party. If County breaches its obligations to make the minimum purchase requirements pursuant to Section 2.a. of this Agreement, it shall be deemed to have "materially breached" this Agreement.
- 2. <u>Bankruptcy or Insolvency</u>. This Agreement may be terminated by either party upon notice to the other should the other party (i) become insolvent, or (ii) file a petition under any bankruptcy or insolvency law or have any such petition filed against it which is not stayed within ninety (90) days of such filing.
- 3. County and Integra each reserve the right to terminate this Agreement, for any reason, with a thirty (30) day written notice of termination.
- ii. <u>Certain Rights</u>. Any termination of this Agreement shall be without prejudice to any rights or right of action vested in either party on the date of termination.

8. Limited Product Warranty.

- a. Integra warrants that it will convey good title to each Product sold to County under this Agreement, free from any security interest, lien or other encumbrance.
- b. Integra warrants that the Products supplied to County under this Agreement will, at the time of delivery, conform to Integra's standard limited warranty that is provided on a Product by Product basis.
- c. INTEGRA MAKES NO WARRANTIES OTHER THAN THOSE STATED IN THIS AGREEMENT. INTEGRA DISCLAIMS ANY AND ALL IMPLIED WARRANTIES, INCLUDING BUT NOT LIMITED TO, IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, AND ANY IMPLIED WARRANTY ARISING FROM COURSE OF PERFORMANCE, COURSE OF DEALING, USAGE OF TRADE OR OTHERWISE.
- 9. <u>Limitation of Liability</u>. EXCEPT FOR LIABILITY ARISING FROM INTEGRA'S GROSS NEGLIGENCE, WILLFUL MISCONDUCT, VIOLATION OF LAW OR INDEMNITY OBLIGATIONS, THE LIABILITY OF INTEGRA AND ITS AFFILIATES IN THE AGGREGATE UNDER AND WITH RESPECT TO THIS AGREEMENT AND THE PERFORMANCE OR NONPERFORMANCE OF THIS AGREEMENT AND ANY PRODUCTS (INCLUDING, WITHOUT LIMITATION, THE PRODUCTS) FURNISHED UNDER THIS AGREEMENT SHALL BE LIMITED TO TWO TIMES (2X) THE VALUE OF THE PRODUCTS PURCHASED BY COUNTY IN THE CALENDAR YEAR IN WHICH THE LIABILITY ARISES. NEITHER PARTY SHALL BE LIABLE FOR ANY INCIDENTAL, INDIRECT, SPECIAL, PUNITIVE OR CONSEQUENTIAL DAMAGES, LOSS OF PROFIT, OR LOSS OF USE.

10. Indemnification and Insurance

- Indemnification. Integra will indemnify, defend, and hold harmless County and its officers, employees, agents and volunteers, from any and all third party claims, costs (including without limitation reasonable attorneys' fees), and losses for infringement of any United States patent, copyright, trademark or trade secret (Intellectual Property Rights) by any Products. If a credible claim is made or threatened, including without limitation the filing of a lawsuit against County, or County receives a demand or notice claiming actual or potential infringement or misappropriation of any Intellectual Property Rights, County will use reasonable efforts to notify Integra promptly of such lawsuit, claim or election. However, County's failure to provide or delay in providing such notice will relieve Integra of its obligations only if and to the extent that such delay or failure materially prejudices Integra's ability to defend such lawsuit or claim. County will give Integra sole control of the defense (with counsel reasonably acceptable to County) and settlement of such claim; provided that Integra may not settle the claim or suit absent the written consent of County unless such settlement (a) includes a release of all claims pending against County, (b) contains no admission of liability or wrongdoing by County, and (c) imposes no obligations upon County other than an obligation to stop using the Products that are the subject of the claim. In the event that Integra fails to or elects not to defend County against any claim for which County is entitled to indemnity by Integra, then Integra shall reimburse County for all reasonable attorneys' fees and expenses within thirty (30) days from date of invoice or debit memo from County. After thirty (30) days, County will be entitled to deduct any unpaid invoice or debit memo amount from any amounts owed by County to Integra. This shall not apply to any judgment or settlement amount, which amounts County shall be entitled to notify, invoice or debit Integra's account at any time; and County, at its sole discretion, may settle the claim or suit.
- b. Insurance Requirements. Integra agrees to provide insurance set forth in accordance with the requirements herein. If Integra uses existing coverage to comply with these requirements and that coverage does not meet the specified requirements, Integra agrees to amend, supplement or endorse the existing coverage to do so. Without in any way affecting the indemnity herein provided and in addition thereto, Integra shall secure and maintain throughout the contract term the following types of insurance with limits as shown:
 - i. Workers' Compensation/Employer's Liability A program of Workers' Compensation insurance or a state-approved, self-insurance program in an amount and form to meet all applicable requirements of the Labor Code of the State of California, including Employer's Liability with \$250,000 limits covering all persons including volunteers providing services on behalf of Integra and all risks to such persons under this Agreement. If Integra has no employees, it may certify or warrant to County that it does not currently have any employees or individuals who are defined as "employees" under the Labor Code and the requirement for Workers' Compensation coverage will be waived by the County's Director of Risk Management. With respect to contractors that are non-profit corporations organized under California or Federal law, volunteers for such entities are required to be covered by Workers' Compensation insurance.
 - ii. <u>Commercial/General Liability Insurance</u> Integra shall carry General Liability Insurance covering all operations performed by or on behalf of Integra providing

coverage for bodily injury and property damage with a combined single limit of not less than one million dollars (\$1,000,000), per occurrence. The policy coverage shall include:

- 1. Premises operations and mobile equipment.
- 2. Products and completed operations.
- 3. Broad form property damage (including completed operations).
- 4. Explosion, collapse and underground hazards.
- 5. Personal injury.
- 6. Contractual liability.
- 7. \$2,000,000 general aggregate limit.
- iii. Automobile Liability Insurance Primary insurance coverage shall be written on ISO Business Auto coverage form for all owned, hired and non-owned automobiles or symbol 1 (any auto). The policy shall have a combined single limit of not less than one million dollars (\$1,000,000) for bodily injury and property damage, per occurrence. If Integra is transporting one or more non-employee passengers in performance of contract services, the automobile liability policy shall have a combined single limit of two million dollars (\$2,000,000) for bodily injury and property damage per occurrence. If Integra owns no autos, a non-owned auto endorsement to the General Liability policy described above is acceptable.
- iv. <u>Umbrella Liability Insurance</u> An umbrella (over primary) or excess policy may be used to comply with limits or other primary coverage requirements. When used, the umbrella policy shall apply to bodily injury/property damage, personal injury/advertising injury and shall include a "dropdown" provision providing primary coverage for any liability not covered by the primary policy. The coverage shall also apply to automobile liability.
- c. If insurance coverage is provided on a "claims made" policy, the "retroactive date" shall be shown and must be before the date of the start of the contract work. The claims made insurance shall be maintained or "tail" coverage provided for a minimum of five (5) years after contract completion.
- d. Additional Insured All policies, except for Worker's Compensation, Errors and Omissions and Professional Liability policies shall contain additional endorsements naming the County and its officers, employees, agents and volunteers as additional named insured with respect to liabilities arising out of the performance of services hereunder, but only to the extent of liabilities assumed by Integra under this Agreement. The additional insured endorsements shall not limit the scope of coverage for the County to vicarious liability but shall allow coverage for the County to the full extent provided by the policy. Such additional insured coverage shall be at least as broad as Additional Insured (Form B) endorsement form ISO, CG 2010.11 85.
- e. Waiver of Subrogation Rights Integra shall require the carriers of required coverages to waive all rights of subrogation against the County, its officers, employees, agents, volunteers, contractors and subcontractors. All general or auto liability insurance coverage provided shall not prohibit Integra and Integra's employees or agents from waiving the right of subrogation prior to a loss or claim. Integra hereby waives all rights of subrogation against the County, but only to the extent of liabilities assumed by Integra under this Agreement.

- f. <u>Policies Primary and Non-Contributory</u> All policies required herein are to be primary and non-contributory with any insurance or self-insurance programs carried or administered by the County.
- g. <u>Severability of Interests</u> Integra agrees to ensure that coverage provided to meet these requirements is applicable separately to each insured and there will be no cross liability exclusions that preclude coverage for suits between Integra and County or between County and any other insured or additional insured under the policy.
- h. Proof of Coverage Integra shall furnish Certificates of Insurance to the County Department administering the Agreement evidencing the insurance coverage at the time the Agreement is executed, additional endorsements, as required shall be provided prior to the commencement of performance of services hereunder, which certificates shall provide that such insurance shall not be terminated or expire without thirty (30) days written notice to the Department, and Integra shall maintain such insurance from the time Integra commences performance of services hereunder until the completion of such services. Within fifteen (15) days of the commencement of this Agreement, Integra shall furnish a copy of the Declaration page for all applicable policies and will provide complete certified copies of the policies and endorsements immediately upon request.
- i. <u>Acceptability of Insurance Carrier</u> Unless otherwise approved by County's Risk Management, insurance shall be written by insurers authorized to do business in the State of California and with a minimum "Best" Insurance Guide rating of "A-VII".
- j. <u>Deductibles and Self-Insured Retention</u> Any and all deductibles or self-insured retentions in excess of \$10,000 shall be declared to and approved by Risk Management.
- k. Failure to Procure Coverage In the event that any policy of insurance required under this Agreement does not comply with the requirements, is not procured, or is canceled and not replaced, County has the right but not the obligation or duty to terminate the Agreement or obtain insurance if it deems necessary and any premiums paid by the County will be promptly reimbursed by Integra or County payments to Integra will be reduced to pay for County purchased insurance.
- 1. <u>Insurance Review</u> Insurance requirements are subject to periodic review by County. The County's Director of Risk Management or designee is authorized, but not required, to reduce, waive or suspend any insurance requirements whenever County determines that any of the required insurance is not available, is unreasonably priced, or is not needed to protect the interests of County. In addition, if County determines that heretofore unreasonably priced or unavailable types of insurance coverage or coverage limits become reasonably priced or available, the County's Director of Risk Management or designee is authorized, but not required, to change the above insurance requirements to require additional types of insurance coverage or higher coverage limits, provided that any such change is reasonable in light of past claims against the County, inflation, or any other item reasonably related to the County's risk.
- m. Any change requiring additional types of insurance coverage or higher coverage limits must be made by amendment to this Agreement. Integra agrees to execute any such amendment within thirty (30) days of receipt.

n. Any failure, actual or alleged, on the part of County to monitor or enforce compliance with any of the insurance and indemnification requirements will not be deemed as a waiver of any rights on the part of County.

11. Miscellaneous.

- Confidentiality. County agrees not to disclose Confidential Information (as defined below), to any third party, except that County may disclose the terms of this Agreement, pricing arrangements and any other Confidential Information (i) as required by law and (ii) to federal and state health care payors (including without limitation, Medicare and Medicaid payors) and to other health care regulators. "Confidential Information" is any information, whether in writing or disclosed orally to County, including without limitation, all information relating to existing and potential customers, suppliers, markets, contracts, products, procedures, technologies, know-how, processes, inventions, developments, methods of manufacture or any other information relating to Integra and its affiliates, except to the extent that any such information as of the date of disclosure to County was (i) known to County and such knowledge can be substantiated by reasonable documentation; (ii) disclosed in published literature; (iii) generally available to the industry; or (iv) obtained by County from a third party, provided that such third party had no obligation of confidentiality to Integra or any of its affiliates relating to the information. This Agreement is subject to local and state open meetings and public records laws, including without limitations, the San Bernardino County Sunshine Ordinance, County Code of Ordinances Section 19.0101, California Government Code 54950, and California Public Records Act (Government Code Section 6250).
- b. <u>Indirect Purchases</u>. Purchases made through a third-party wholesale distributor (a "Distributor") are subject to the terms and conditions negotiated between the Distributor and the County (e.g., payment terms, service fees, shipping fees and product surcharges). A Distributor will be responsible for delivering all Products purchased by the Participant through that Distributor.
- c. <u>Additional Products</u>. Integra may at its discretion add products (e.g. Product extensions, New Products) to Schedule 2 after providing notice to the County.
- d. <u>Notices</u>. All notices, demands or other communications required or permitted to be given pursuant to this Agreement shall be effective only if given in writing, hand-delivered, faxed to the numbers set forth below, with receipt confirmed, or sent by courier service or certified or registered mail, return receipt requested, postage prepaid and addressed as follows:

e. <u>Governing Law; Venue; Attorneys' Fees</u>. This Agreement shall be construed, interpreted and enforced in accordance with, and governed by, the laws of the State of California, without giving effect to choice of law principles. The parties acknowledge and agree that this Agreement was

entered into and intended to be performed in San Bernardino County, California. The parties agree that the venue of any action or claim brought by any party to this Agreement will be the Superior Court of California, County of San Bernardino, San Bernardino District. Each party hereby waives any law or rule of the court, which would allow them to request or demand a change of venue. If any action or claim concerning this Agreement is brought by any third party and filed in another venue, the parties hereto agree to use their best efforts to obtain a change of venue to the Superior Court of California, County of San Bernardino, San Bernardino District. If any legal action is instituted to enforce any party's rights hereunder, each party shall bear its own costs and attorney fees, regardless of who is the prevailing party. This paragraph shall not apply to those costs and attorney fees directly arising from a third-party legal action against a party hereto and payable under Indemnification and Insurance Requirements.

- f. Assignment and Binding Effect. This Agreement is personal and County may not assign, transfer (including transfers by operation of law) or otherwise dispose of all or any portion of its rights under this Agreement without the prior written consent of Integra, and any such purported assignment will be void. Without the prior written consent of County, this Agreement is not assignable by Integra either in whole or in part. This Agreement shall be binding on the respective successors and permitted assigns of the parties hereto.
- g. Remedies. No remedy herein conferred is intended to be exclusive of any other remedy, and each and every such remedy shall be cumulative and shall be in addition to every other remedy given hereunder or now or hereafter existing at law or in equity or by statute or otherwise. Integra and County each acknowledge that damages alone may not be an adequate remedy for any breach or violation of its obligations hereunder and that in addition to any other remedies to which the other party may be entitled hereunder or otherwise, such other party shall be entitled to injunctive relief, including specific performance, with respect to such obligations in any court of competent jurisdiction.
- h. <u>Waivers</u>. No waiver by any party hereto or any failure by any other party hereto to keep or perform any covenant or condition of this Agreement shall be deemed to be a waiver of any preceding or succeeding breach of the same or other covenant or condition. No failure to enforce any provision hereof shall operate as a waiver thereof or be deemed to be a release of any rights granted hereunder.
- i. <u>Severability</u>. If any provision of this Agreement would be held or made invalid or unenforceable by a court decision, statute, rule or otherwise, such provision shall be construed in such a way as to make it valid and enforceable to the maximum extent possible. The invalidity or unenforceability of any provision of this Agreement shall not affect the remaining provisions of this Agreement, which shall be enforceable to the maximum extent permitted by law.
- j. <u>Entire Agreement</u>. The parties acknowledge that this Agreement and any attachments, schedules, exhibits and riders hereto constitute the complete and exclusive understandings between the parties with respect to the subject matter of this Agreement. No amendment of this Agreement may be made or rider added except in a writing duly signed by an authorized representative of each of the parties hereto.
- k. <u>Headings</u>. The headings in this Agreement are for convenience of reference only and in no way define or limit any of the provisions hereof or otherwise affect their construction or effect.
- 1. <u>Counterparts</u>. This Agreement may be executed in multiple counterparts, each of which shall be deemed an original, but all of which shall constitute one and the same instrument.

- m. <u>Survival</u>. The provisions of Sections 3, 5, 6, 7(b)(ii), 8, 9 and 10 shall survive the termination of this Agreement for any reason.
- n. <u>Debarment and Suspension</u>. Integra certifies that neither it nor its principals or subcontracts is presently disbarred, suspended, proposed for debarment, declared ineligible, or voluntarily excluded from participation in this transaction by any federal department or agency. (See the following United States General Services Administration's System for Award Management website https://www.sam.gov). Integra further certifies that if it or any of its subcontractors are business entities that must be registered with the California Secretary of State, they are registered and in good standing with the Secretary of State.
- o. <u>Improper Consideration</u>. Integra shall not offer (either directly or through an intermediary) any improper consideration such as, but not limited to cash, discounts, service, the provision of travel or entertainment, or any items of value to any officer, employee or agent of County in an attempt to secure favorable treatment regarding this Agreement. County, by written notice, may immediately terminate this Agreement if it determines that any improper consideration as described in the preceding paragraph was offered to any officer, employee or agent of County with respect to the proposal and award process. This prohibition shall apply to any amendment, extension or evaluation process once a contract has been awarded. Integra shall immediately report any attempt by a County officer, employee or agent to solicit (either directly or through an intermediary) improper consideration from Integra. The report shall be made to the supervisor or manager charged with supervision of the employee or the San Bernardino County Administrative Office. In the event of a termination under this provision, County is entitled to pursue any available legal remedies.
- p. <u>Relationship of the Parties</u>. Nothing contained in this Agreement shall be construed as creating a joint venture, partnership, or employment arrangement between the Parties hereto, nor shall either Party have the right, power or authority to create an obligation or duty, expressed or implied, on behalf of the other Party hereto.
- q. <u>Release of Information</u>. No news releases, advertisements, public announcements or photographs arising out of the Agreement or Integra's relationship with County may be made or used without prior written approval of Hospital.
- r. Right to Monitor and Audit. The County, State and Federal government shall have absolute right to review and audit all records, books, papers, documents, corporate minutes, and other pertinent items as requested, and shall have absolute right to monitor the performance of Integra in the delivery of Products provided under this Agreement. Integra shall give full cooperation, in any auditing or monitoring conducted. Integra shall cooperate with County in the implementation, monitoring, and evaluation of this Agreement and comply with any and all reporting requirements established by County. All records pertaining to Products delivered and all fiscal, statistical and management books and records shall be available for examination and audit by County representatives for a period of three years after final payment under this Agreement or until all pending County, State and Federal audits are completed, whichever is later.
