The Board of Supervisors of the County of San Bernardino, State of California,
acting in its capacity as the governing body of County Service Area 70, ordains as
follows:

Employee Election Worker Program.

(b) California Elections Law requires that election workers attend a training session prior to each election. This training will be conducted by the Registrar of Voters during and after regular work hours. Employees will be encouraged to attend training during their regular work hours.

1 (c) Any additional equipment or supplies necessary to carry out Election
2 Worker duties on Election Day will be provided by the Registrar of Voters. The
3 Registrar of Voters will keep the Special Districts Department Director or designee
4 informed of employees who volunteer for service on Election Day in terms of their
5 attendance.

6 (d) The Registrar of Voters will reimburse the Special Districts Department
7 for the compensation the employee receives while in election worker training.
8 Regardless of whether the hours worked as an Election Worker on or before Election
9 Day count as overtime, the Registrar of Voters will reimburse the Special Districts
10 Department for any weekly overtime that the department is liable for due to the
11 employee working as an Election Worker on Election Day.

12 (e) This ordinance shall remain in effect until January 16, 2025, and as of
13 that date is repealed, unless a later ordinance that is enacted and effective before
14 January 16, 2025, deletes or extends that date.

16 SECTION 2. This ordinance shall take effect 30 days from the date of
17 adoption.
